1. The United Nations is seeking to establish a contract for provision of Long Term Air Charter Services for One Medium Fixed Wing Cargo aircraft, to be used in support of MONUSCO,DRC.
2. The aircraft shall be capable of transport minimum one 20 Foot ISO container weighting minimum 10 metric tons. The aircraft cargo door must have a ramp access to allow loading of wheeled vehicles and two sets of loading kits for 20-foot ISO container.
- 3 Aircraft must be capable fly from Kinshasa (FZAA) to Entebbe (EBB) at normal cruise level and speed with payload minimum of 10 metric tons of cargo plus reserves for IFR diversion.
4. The initial operational base will be Entebbe, Uganda. The Aircraft must be able to operate from the following locations but not limited to Bunia, Entebbe, Beni, Bukavu, Goma, Kalemie and Kinshasa:
5. Answers to the RFI should come from companies with proven experience for projects of similar scope and profile. Because of the highly dynamic nature of the flight operations in the UN Field Missions specialized and extensive breadth of this project, Air Operators are expected to have substantial and proven record of accomplishment and demonstrable expertise in the required disciplines.
6. Vendor Response Forms and Questionnaire must be completed in full. The UN reserves the right to reject Expressions of Interest documents that are incomplete, or are received after the stated deadline. The Procurement Division reserves the right to change or cancel this request at any time.
