### **DESCRIPTION OF REQUIREMENTS**

The United Nations Joint Staff Pension Fund (UNJSPF) established by the General Assembly of the United Nations (UN) has its offices at 820 2nd Avenue in New York City.

The Office of Investment Management (OIM) of UNJSPF is responsible for ensuring the security of the Fund's investments, enhancing business applications and information systems infrastructure, as well as supporting the front-to-back investment operation processes; it seeks to ensure that these services not suffer any interruption in delivery in the event of a disaster or any incident that would otherwise prevent its staff from reporting to work at the office's regular location.

As a result, OIM is seeking to identify service providers with extensive experience in providing remote office locations with fully equipped office space that could be used as a business continuity site and/or additional ad-hoc office space.

The office space provided by the selected service provider shall be used as alternative remote office location for critical staff when there is a need to work from a facility other than OIM's regular offices or when additional office space may be temporarily needed.

The remote office location project is part of Business Continuity operations at OIM that will help OIM staff to work from remote office locations on an as-needed basis as well as in an event of a disaster.

## SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

Requirements (Scope of Work) for the remote location office space will be as follows, but not limited to:

- Enterprise level network configuration with 24/7 remote monitoring and dashboard access for security and network activities including network utilization report. continuous monitoring ability and availability.
- Redundant Ability for Internet connectivity from multiple diverse service providers with enablement of quality of service (QoS).
- Dedicated office space with minimum 28 seats and one large conference room and smaller conference rooms.
- Ability to provide access to office space globally is desirable.
- Collaboration technology Audio/video conferencing ability in every conference room.
- Dedicated space for investment trading with physical security control is desirable.
- Provision of basic IT and network support.
- Ability for online guest registration, room bookings, conference bookings etc.
- Support with network services, such as DNS, DHCP, NTP, SNMP, etc.
- Network support with Private Wired LAN, Private/dedicated wireless SSID (WI-FI with WPA2 or stronger), Public Static IP, VOIP Phones.
- Network support for connectivity to Bloomberg and/or other private cloud services including support for the private lease lines that terminates in the provider's data center.
- Support for on-demand printing, scanning and Wi-Fi / Ethernet internet services to be available at all times
- Support with robust redundant internet connectivity for UNOIM cloud applications, such as Office 365, SharePoint.
- Support for platform as per OIM's requirements including Azure, Microsoft Windows, UNIX, AWS, Oracle Google and any other private or public clouds as per OIM's future requirements. Insulated, soundproof and up to date technology and equipment's.
- Industry driven RTO and RPO timelines.
- Enterprise level IT and physical security
- SLA including response time and escalation procedure with defined KPI, 99.9 percent network availability.

In order to be eligible for UN registration, you must declare that:

- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
