#### **DESCRIPTION OF REQUIREMENTS**

## Background and objectives:

The 2030 Agenda for Sustainable Development represents an historical international commitment to responsible growth, shared prosperity and reduced poverty. It aims to improve the conditions of life for people, protect the environment and defend peace and inclusive societies. This ambitious vision calls for strong governance and well-crafted public policies to effectively balance the economic, social and environmental priorities of each country. Analytical tools can be an invaluable tool for policy makers to help shape and inform coherent policy design and formulation.

Towards this end, the EAPD/DESA and partners are developing and disseminating a suite of modelling tools specifically designed to help assess the interlinked and intertwined issues that decision-makers grapple with when trying to chart a sustainable development pathway for their country.

To support this, the UN is looking into the possibility of engaging a contractor to assist with tool development, data collection and management, model development and deliver training workshops.

The contractor will undertake the following responsibilities:

- A. Develop a data template and script for use by UN staff and experts to upload data into CLEWs models implemented with the OSeMOSYS modelling system using the open source Model Management Infrastructure system (MoManl) with the following functionality:
- a) The template will allow users to specify the model structure in a parameter file, and will build the sets and technologies required for the specified structure;
- b) The script will automate the process of populating the CLEWs model with set members in the technologies, commodities, emissions, years and time-slice categories based on specifications by the user;
- c) The script will automate the process of creating interlinkages within the model by populating data for

the InputActivityRatio and OutputActivityRairo parameters, based on tabular information specified by users;

- d) The script will be made available and accessible to the analytic community in Member States without restriction. It will be published online as open-source software on Github or similar platform.
- B. Collection and management of data to support Climate, Land, Energy and Water systems (CLEWs) model development in in Ethiopia and Cameroon in collaboration with Member State representatives and other UN contractors. Data and documentation should be uploaded to a shared storage location (e.g. OneDrive) where project stakeholders can access relevant information.
- a) Work with national consultants, national counterparts and external experts to collect and process relevant data from national and international sources
- b) Work with national consultants, national counterparts and external experts to manage a data repository for collected data that allows project participants access to all relevant data in a convenient format for CLEWs analysis and model development
- C. Develop CLEWs model in Ethiopia and support model development in Cameroon with the templates developed under A). Model structure and scenarios must be tailored and adapted to national conditions and analysis objectives as agreed with national counterparts. In particular:
- a) CLEWs models should be developed with base year, time-horizon and time resolution as agreed with national counterparts
- b) CLEWs models should be calibrated to the most recent base year for which data has been provided by national counterparts
- c) CLEWs models should follow UNDESA naming conventions and remain consistent with UNDESA visualization tools
- d) CLEWs models should include technology representation, commodity selection emission selection and regionalization as agreed with national counterparts
- e) CLEWs models should incorporate relevant interlinkages between the land, energy and water systems as agreed with national counterparts
- D. Participate as trainer in remote learning sessions on CLEWs through development of training materials (Supporting documents, exercises, excel workbooks and other materials) and provide lectures, instructions and guidance during teleconference.
- E. Participate as trainer in 3 national workshops on CLEWs, by developing training materials (Supporting documents, exercises, excel workbooks and other materials), delivering lectures and providing support and guidance during hands-on exercises.
