DESCRIPTION OF REQUIREMENTS

The United Nations Procurement Division (UNPD) is seeking information from vendors on supply and delivery of suitable 8x8 High Mobility Recovery Trucks to support the United Nations Multidimensional Integrated Stabilization Mission in Mali (MINUSMA). Please find detailed information in Annex A, attached.

The recovery trucks are intended to be deployed when fuel and cargo trucks breakdown. The recovery trucks should be robust enough to support such breakdowns, as well as operate in rough terrain conditions.

The vehicles may be brand new, or refurbished but in excellent condition, and consistent with the specifications attached as Annex B.

Vendors are requested to review the RFI document in entirety and provide the information requested therein by end of day on Monday July 27 2020.

ANNEX A

INTRODUCTION

The purpose of this Request for Information (RFI) is to understand the market situation relevant to availability of six (6) 8x8 High Mobility Recovery Trucks (and the provision of relevant after sales support services such as spare parts, training, technical support, etc. for United Nations Multidimensional Integrated Stabilization Mission in Mali (MINUSMA) and, prior to undertaking a solicitation exercise, to identify Vendors that can provide these trucks. The trucks can be offered new or used. If used, Vendors shall indicate the odometer readings of each truck and its mechanical condition.

Please note that the RFI process is separate and independent from the solicitation and shall not be considered as a solicitation.

All costs for preparing a response for the RFI shall be covered by the Vendor.

1. USE OF INFORMATION

This RFI is not intended to solicit proposals from prospective vendors, but to gather information that would help the UN understand the market situation. Responses to this RFI will not be used to pre-qualify vendors.

This RFI seeks to collect information/data that will be used to understand capabilities in the Market and indicate general pricing. <u>Submitted information will be used by the UN</u> for internal planning purposes and shall be kept strictly confidential.

Provided information will not be:

- a. Used to pre-qualify vendors but may be a basis to invite [RFI] respondents to participate in the solicitation, once issued.
- b. Contractually binding to the Vendor or to the UN.

3. RFI RESPONSE FORMAT AND FOLLOW UP METHOD

The UN requests that suppliers provide as much information as they can to the questions in Section 6 below. It is not mandatory to answer all the questions in Section 6 but it is preferred.

Subsequent to this RFI and the submissions received, the UN may seek clarifications to the information provided by your organization. In your response, kindly advise an appropriate contact i.e. name, email address and telephone number, to whom the UN may request such clarification.

4. CURRENT SITUATION AND GOALS

- 4.1 The United Nations (UN) is seeking information on availability, accessibility, supply and delivery of six (6) 8 x 8 High Mobility Recovery Vehicles (as per attached techncial specifications in annex B, and after sales support services for these trucks such as spare parts, training, techncial support, et. in support of the United Nations Multidimensional Integrated Stabilization Mission in Mali (hereinafter referred to as "MINUSMA").
- 4.2 Trucks may be new or used, and consistent with the technical details provided in Annex B.
- 4.3 The estimated quantity of vehicles required is six (6).

5. TECHNICAL ASPECTS DESCRIPTION

Support and Logistics Aspects

- 5.1 The UN maintenance policy is such that MINUSMA personnel will be responsible for operating and carrying out the maintenance and repair works at UN facilities in order to guarantee the operational availability of the fleet. For this reason, the Vendor(s) shall be requested to provide a full logistic support package to be continued throughout the whole life cycle of the trucks, estimated to be 15 years. For this purpose, vendor(s) shall be required, to the extent possible, to provide:
 - Spare parts (and assemblies) supply (OEM parts).
 - Warranty services.
 - Technical documentation.
 - Special Tools and Equipment supply.
 - UN personnel training.
 - Technical Support and Advice.
 - Delivery services.
 - Maintainability, Reparability and Testability (MRT) issues.
 - Local Dealerships.

Spare Parts

5.2 The operation and maintenance of these trucks will be performed by MINUSMA technicians. Therefore, the vendor should be able to provide effective spare parts support including spare parts catalogues. The Vendor(s) will warrant and represent that they shall supply spare parts to the UN during the entire life-cycle of the trucks (i.e. 15 years beyond the date the trucks are put into operation).

Warranty

5.3 The UN seeks 2 years warranty for the offered trucks if offered as new and are encouraged to provide a warranty for the used vehicles if offered (to be determined by the vendor)

Technical documentation

5.4 All publications and related material are to be available in both English and French. The Vendor(s) will provide the following manuals as a minimum: operator's manual, tools and equipment manual, spare parts manual, and workshop manual.

Special tools and equipment supply

5.5 Each truck is to be equipped with a basic tool kit as a standard feature. The Vendor(s) are to provide details of the component parts of each tool kit in the technical proposal.

UN personnel training and technical support and advice

5.6 It is anticipated that UN personnel will perform all routine and corrective maintenance tasks. Maintenance work will be carried out at different levels, ranging from the basic level until the depot level. For this reason, the Vendor(s) may have to provide enough training courses at different levels to ensure that UN personnel acquire necessary skills for the correct operation and maintenance of the vehicles.

Delivery services

5.7 The UN normally purchase vehicles and spare parts on an FCA Port of Exit basis (INCOTERMS 2010), or on a DAP Final Destination Basis (INCOTERMS 2010) if the Vendor(s) provides such delivery. Please indicate delivery preference.

Local Dealership

5.8 Availability of a dealership is a plus. The UN wishes to use local dealer(s) present in Mali, or surrounding countries, to provide required part of the after sales support services and therefore, the UN prefers suppliers who have authorized dealers in Mali, or the surrounding countries.
