DESCRIPTION OF REQUIREMENTS

Background

United Nations Peace Operations deploy civilian, police and military personnel worldwide, often in areas with ongoing armed conflicts. In order to support mandate implementation, Peacekeeping Intelligence operations are conducted, aiming on collecting and subsequent analysis of information. Every Peace Operation is maintaining a network to provide ICT services. Due to the inherent confidentiality of collected data from peacekeeping intelligence process, it is required to utilize a dedicated, highly secured, separated network which can ensure the confidentially of the data. This Request for Information is to identify commercial vendors that may be able to provide such a network and services to one or multiple peace operations aiming to a future Request for Proposals.

The requirement at hand

This request for information seeks to identify vendors able to design, deploy, operate and maintain a Secure Network Services capability, including hardware, training, maintenance and, potentially operations of such systems. Vendors should be able to provide to one or multiple peace operations in order to provide a resiliency and ensure a high availability (24/7):

- 1) This Secure Network requested is to be completely closed without any connection to other networks. All exchanged data shall be encrypted and equipped with a strict access control.
- 2) This Network shall provide the following secure services for up to 100 end users located at each point of presence (POP), the number of POP dependent on the mission, estimated between 3-7: Email, Voice, VTC: Point to point and point-multipoint, Chat, FAS (Functional Area Services)
- 3) The architecture of the system shall provide high scalability (up to 1,000 total end users) if additional sites, users or services will be requested in order to expend the deployed network.
- 4) The system shall be designed with a full redundant equipment; WAN links (SATCOM and lease lines, if available in country) will be provided by the United Nations.
