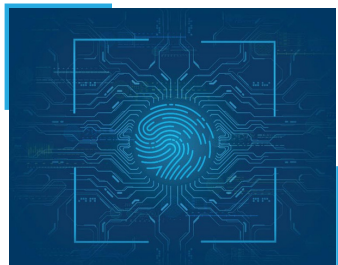


## UN Countering Terrorist Travel Programme



The **Countering Terrorist Travel Programme ('CT Travel')**, a flagship global initiative of the **United Nations Office of Counter-Terrorism (UNOCT)**, assists Member States in building their capabilities to detect and counter terrorists and other serious criminals by using Advance Passenger Information (API) and Passenger Name Record (PNR) data.

### CT Travel has developed four eLearning modules:

- 1 API and PNR;
- 2 International Legal Framework for the use of API and PNR;
- 3 PIU and PDSW; and
- 4 Hit and Match in a PIU and OSINT, that are available on the UN Learning Management System.

**These modules** act as a **pre-training course** for nominated officials from beneficiary Member States attending their national consultations on **API** and **PNR**. The four modules will also be available to officials from Member States wishing to join the Programme. The **eLearning modules** are **self-paced** and participants can complete them anywhere at a time suitable according to their schedule.



## OBJECTIVES

The **eLearning modules** are the first step in the CT Travel training roadmap. After the successful completion of these modules, the national consultation on API and PNR will take place. This will be followed by the CT Travel interactive training course which nominated officials will attend (online, hybrid format, or in-person). After which the nominated officials are required to take part and complete the online quiz successfully and can get the certificate.

Following these training steps in CT Travel, the national implementation begins.



## TARGET AUDIENCE

The target audience is representatives from governments, practitioners in the field of countering terrorist travel and PIU staff who will be involved in establishing API and PNR capabilities in their Member State. No previous experience or knowledge is required.



## STRUCTURE

Self-paced eLearning modules, take approximately 40 minutes to be completed.

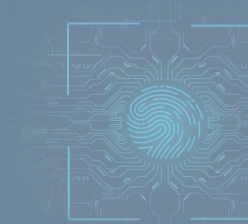
