








CONCEPT NOTE

Launch event of new training materials on Human Rights at International Borders Monday, 25 October 2021, 10:00 to 11:30 AM EDT/ 16:00 – 17:30 CEST

The UN Office of Counter-Terrorism (UNOCT) and Office of the UN High Commissioner for Human Rights (OHCHR) are launching the jointly developed <u>Human Rights at International Borders: A Trainer's Guide.</u>

This capacity building tool has been developed based on OHCHR's human rights training methodology and draws on and complements the OHCHR Recommended Principles and Guidelines on Human Rights at International Borders.

The Trainer's Guide aims to assist Member States in ensuring border governance is human rights-based and gender-responsive. It recognises that the work of border officials is just as much about



ensuring the well-being of migrants and communities as it is about upholding human rights and protecting the rule of law. Indeed, border officials are often first responders in providing assistance and protection to people in vulnerable situations. The capacity building materials thus provide practical guidance for frontline border officials to carry out their critical functions in a human rights-based and gender-responsive manner.

The development of this Trainer's Guide has been informed by pilots with border officials in various regions, as well as inputs by border officials and other practitioners and experts. It employs an interactive training methodology based on a practical approach, which focuses on the relevance of human rights in the work of border officials.

Objective


