Subject : SIOFA contribution on sustainable fisheries management in the face of Climate Change

Dear Sir,

In response to the letter from M. Miguel de Serpa Soares, Under-Secretary-General for Legal Affairs and United Nation Legal Counsel, please find below the contribution of the Southern Indian Ocean Fisheries Agreement (SIOFA) concerning the Sustainable fisheries Management in the face of Climate Change.

SIOFA is a Regional Fisheries Management Organisation of ten years old, in charge of ensuring the long-term conservation and sustainable use of the fishery resources in <u>high seas</u> of a maritime area of nearly 30 millions of km2, except the hight migratory species that are under Indian Ocean Tuna Commission competence.

One of the main tasks of SIOFA during these 10 first years has been to collect enought data to be able to assess the different stocks of mains fisheries, identify the potential Vulnerable Marine Ecosystem, define Harvest strategies management objectives, and put in place a Workplan able to allow the fisheries under a precautionary approach, while preserving surrounding ecosystems.

The works and projects initiated and supervised by the SIOFA Scientific Committee are now available in free access, on SIOFA website https://siofa.org/science/sc-works

Climate change, notably in the marine environment, is causing increasing concern. Sevreral RFMOs are working to integrate response measures into their processes and decision attended to several international.

SIOFA has been invited by FAO, to collaborate in workshop on Mainstreaming Climate Change into international Fisheries Governance. Theses workshops allows us to identify what has been done in other RFMOs in order to transmit theses informations to the Meeting of the Parties, waiting therefore for a more detailed guideline for the next future.

The 9^{th} Scientific Committee that has been held from 18^{th} to 27^{th} March 2024 has considered the Climate Changes and has done several recommendations that will be presented to the 11^{th} Meeting of the Parties scheduled from 1^{st} to 5^{th} of July 2024.

It will be up to the Meeting of the Parties to prioritize and funds the action to be taken in order to eventualy develop a workplan to promote climate-resilient fisheries management, define which indicators are necessary to assess and adress the impacts of climate change on fisheries,

Southern Indian Ocean Fisheries Agreement (SIOFA/APSOI) 13 rue de Marseille, 97420 Le Port - La Réunion introduce the climate change factor in the report in order to update the regulation framework of ${\sf SIOFA}.$
