Least Developed Countries = Low-income countries + facing structural handicaps to sustainable development

- GNI per capita (as a measure of income)
- Structural impediments to sustained sustainable development:
 - Level of human development measured by the Human Asset Index (HAI),
 - Structural vulnerability to shocks proxied by the Economic Vulnerability Index (EVI)
- Special international support measures needed to help LDCs address problems of under-development





Special International Support Measures for LDCs

- Official Development Assistance:
 ⇒ Financial flows and technical assistance
 ⇒ Bilateral and multilateral donors
- International trade:
 ⇒ SDT in WTO obligations
 - Market Access

Other forms of support:

- ⇒ Caps to contribution to UN budget, discounts in contributions PKO
- ⇒ Travel funds
- ⇒ Others
 - Since 1981, support by the development partners framed by the Programmes of Action for LDCs

- **Limited use of many support measures by few LDCs**
- Surveys by DESA revealed in many cases a lack of knowledge about support measures
- Lack of information is a potential constraint for using support measures
 Information is often widely dispersed
 Capacity constraints in identifying and knowing how to use support measures





Objectives of LDC Portal

A consolidated platform with all relevant information related to the international support measures specifically made available for the category

Improve LDCs capacity to access information on existing support measures and to make use of such measures

Building capacity in graduating countries in preparing strategies for a smooth transition





How we got there capacity building activities

- Surveys, case studies, policy analysis, macro-economic framework
- 57 survey participants: LDCs, bilateral donors, multilateral organizations, trading partners
- Collaborative effort: EIF, ITC, OECD/DAC, OHRLLS, STDF, UNCTAD, UNDP, WTO
- First launch: IV UN Conference on LDCs in Istanbul, May 2011
- October 2012 launch: redesigned version to improve accessibility, ease of navigation and allow for greater interaction among users






WHAT CAN PORTAL DO TO HELP?

Improving Access to Support Measures
