#### Relaunching Commonwealth Disabled People's Forum

We were pleased to be able to apply to the Commonwealth Fund of the Disability Rights Fund to start up the CDPF again, develop activities and move forward at this important time and be granted money to bring delegates to a launch event in New York during the 12<sup>th</sup> Conference of State Parties in June 2019

## **History**

Following a meeting at CHOGM 2007 of disabled activists in Uganda, it was planned to have a launch meeting in London the following year. The International Committee of the UK Council of Disabled People supported this process. This organisation no longer exists.

The Commonwealth Disability People's Forum was set up at a meeting in London in 2008 supported by DFID and FOC funding. There was a meeting with representatives from 16 Commonwealth Countries which adopted a policy direction, adopted a constitution and elected an executive committee. There was a parallel Youth meeting at the same time which elected 2 representatives to the Executive Board. A training event was held in Kampala the following year organised by James Mwandah the Chair. Unfortunately, in the following year both the Chair and Vice Chair died. The remaining Executive members filled these posts from among their number. More activities and meetings were held through to 2012. These included training in the Commonwealth Islands of the Pacific for disabled organisation leaders, interventions at a number of international meetings in New York, Geneva and Sri Lanka and a presentation of these activities at Marlborough House. By this time 27 country National DPOs were full members and a number of individual or local DPOs were associate members. Illness (the Membership Secretary and the Acting Secretary's death) with failure to get additional funding, led to the organisation ceasing to function. However, a bank account was set up but not used and the CDPF was registered as a company in London. No audited accounts have been produced as any money we raised went through individual DPOs.

Since 2012 there have been a number of important developments which put disability equality, as a development issue, at the centre of the international development agenda. There is a lack of coordination and collaboration of Commonwealth DPOs on policy development, implementation, capacity building and leadership development across the 53 countries (Maldives, the 54<sup>th</sup>, is reapplying for admission). The Commonwealth Foundation has continued to hold occasional disability

event (2016 and 2018), but the Commonwealth Secretariat and member countries have not focused majorly on disability accepting some mentions in the 2018 CHOGM declaration. Now the Commonwealth Secretariat are fully supporting our efforts to relaunch the Commonwealth Disabled People's Forum

## **Recent Developments**

The adoption of the Sustainable Development Goals in 2015 and their clear link with the articles of the Convention on the Rights of Persons with Disabilities, (152 of the 162 targets linked to Human Rights instruments including 11 links on disability) sets a strong agenda. This means collaborating and working to advance these across the Commonwealth. This is a vital priority with over 400 million persons with disabilities. The Global Disability Summit agreed to work in 4 priority areas

At the recent Global Summit on Disability held in London on 23rd and 24th July, a number of members of the previous Commonwealth Disabled People's Forum came together at a meeting with more than 20 representatives and agreed that the time was right to try and restart the Commonwealth Disabled People's Forum. It was decided that this should be carried out at the UN Conference of State Parties in New York 9th to 13th June. We have decided that this should be on Friday June 14th 2019.

At the Summit it was agreed, based on consultation, to move forward with two cross-cutting themes on humanitarian assistance and gender and four themes:

- "1.Tackling stigma and discrimination commitments could included greater legislation at national level; quotas on representation and visibility of people with disabilities; and high-profile media campaigns.
- 2. Inclusion in education deliverables may include: minimum standards of accessibility in schools, and greater leadership and investment in teacher training and accessible learning materials/resources.
- 3. Routes to economic empowerment commitments may include: anti-discrimination laws, social protection and training schemes, vocational rehabilitation and universal design.
- 4. Harnessing technology and innovation this area has significant potential to change lives in low income countries: In terms of deliverables we will target reduced prices and expanded access of five assistive devices through new mass markets; and also improved access to cross the 'digital divide' through new technologies"
- . These will be the areas of initial focus for the reconstituted CDPF. The method we shall use comes from the Civil Society Forum on 23rd July.

On 23 July 2018 (London) over 600 representatives from Organisations of Persons with Disabilities also referred to as DPOs, Civil Society, Governments, Multilateral Organisations, and the Private Sector met to support the implementation and monitoring of the United Nations Convention on the Rights of Persons with Disabilities (CRPD) and Agenda 2030.

"Collaboratively, we wish to convey the following Statement:

We commit to working with all stakeholders here at the Summit to ensure that all persons with disabilities can have full and equal enjoyment of their rights and fundamental freedoms, as set out in the CRPD.

Agenda 2030 is an important opportunity to promote the rights of persons with disabilities globally, and the CRPD should be its guiding framework.

We acknowledge the steps taken to realise the rights of persons with disabilities and their families, by Governments and organisations here today. However, there remains much more to be done.

Today, we call on those present to make measurable, ambitious and lasting commitments. Commitments which will be made a reality and not just stay on paper.

It is time to implement the CRPD in every corner of the world: in every city, in every train station, in every village, in every mountain and valley, in every refugee camp and in every school.

We all, you all, the World Leaders in this room, have a unique opportunity. But also a responsibility.

We call on you all here today to:

Increase the meaningful consultation and involvement of persons with disabilities, and their organisations, in all decision-making processes and follow up of the Summit.

Increase investment in, and partnership with, a diversity of DPOs and support the Disability Rights Movement to grow from the grassroots.

Commit to building the capacity of all stakeholders – government, multilaterals, and broader civil society - to implement the CRPD.

Create stronger partnerships at all levels with an emphasis on the four thematic and two cross-cutting areas of the Summit.

Put in place CRPD compliant policies and legislation, from the national level to overseas development, that are appropriately budgeted for and resourced, and ensures the systematic inclusion of reasonable accommodation as a budgeting principle.

In partnership with persons with disabilities, support the collection and use of appropriate, reliable and comparable data inclusive of persons with disabilities.

Finally, we wish to convey that we fully support the Charter for Change and its effective follow-up.

We thank you for the opportunity to be active participants here today and wish everyone a meaningful and productive Summit".

These will be the structural and organisational focus of the CDPF.

# What - the activities to be funded (meetings to be held, trainings, travel, etc.)?

We need funding for getting delegates from Commonwealth National DPOs to New York to take part in the CRPD and the event on Friday 14th June.

We envisage getting 50 delegates and personal assistants to New York to participate. We have grant money for travel, visas, expenses and accommodation. We think it very important to have a gender balance amongst delegates and represent a range of impairing conditions

The purpose of this one day meeting will be to agree to set up the CRPD, elect a new executive committee, agree key policy priorities in line with the Goals of the Global Summit and enhance participants capacity to get their governments to implement these policies. The International Disability Alliance are fully supporting this initiative as are the UK Department for International Development.

**Further Capacity Building event in 2020**. We would like to hold a further 5 day training and capacity building meeting in 2020 ideally in South Africa in the week before CHOGM with a representative number going on to the CHOGM People's Forum meeting in Rwanda to try and influence the outcome of the Government Communiqué to include an emphasis on disability goals and capacity building for people with disabilities and their DPOs. We aim to get 60 delegates half of whom are youth to this event. This would share experience and knowledge South-South and South –North and North-South
