United Nations

24 Oct 1945 - 29 Dec 1969

The United Nations was officially established in 1945 was a result of the United Nations Conference on International Organization. The United Nations Charter was signed at the conclusion of the United Nations Conference on International Organization by five permanent members of the Security Council.

1st Session of the Temporary Social Commission

29 Apr 1946

The Temporary Social Commission was established by the Economic and Social Council Resolution 7(I) of 16 February 1946, with a mandate to advise the Council in the field of social welfare. The Commission was specifically charged with (a) making a general review of international organization in the social field, (b) reporting and advising the Council on activities in the social field, (b) assuming on an interim basis the work of the League of Nations on such social questions as traffic in women and children and child welfare, and (d) reporting on substantive problems in the social field. The Report of the Temporary

Social Commission recommended that social policy be concerned with ensuring the well-being and satisfactory basis of living for the whole community.

1st Session of the Permanent Social Commission

20 Jan 1947 - 5 Feb 1947

The Permanent Social Commission was established as a permanent functional commission of the Economic and Social Council by the Council's Resolution 10(II) of 21 June 1946. The Commission was given a mandate to assume the functions of the League of Nations in the post-war context, with particular reference to traffic in women and children, child welfare, crime prevention, and housing and town and country planning. Ad hoc Committees included the Temporary Social Welfare Committee and the Committee of Latin American Members. The Report of the First Session recognized the value of close consultation and cooperation with non-governmental organizations and invited the Secretariat to maintain permanent contact with civil society actors.

2nd Session of the Social Commission

28 Aug 1947 - 13 Sep 1947

The Second Session of the Social Commission addressed matters in the social field, such as standards of living, family assistance, child welfare, youth guidance, and social aspects of migration and refugees. Ad hoc Committees included the Drafting Committee on Co-ordination of Events and the Advisory Committee on Planning and Coordination. The Report of the Second Session highlighted the child welfare program, specifically recommending the initiation of studies on social and related problems in under-developed and economically under-privileged areas.

3rd Session of the Social Commission

5 Apr 1948 - 23 Apr 1948

The Third Session of the Social Commission emphasized the indivisibility of the social and economic aspects of the standard of living, and adopted a resolution which resolved the Commission to (a) advise on social aspects of migration with a view to ensure equal social and economic rights, and to (b) provide

advisory social welfare services to governments in the field of family, youth and child welfare. The Report of the Third Session recommended combining the summaries of legislative series on child welfare and of annual government reports. It also advised that reports be prepared on (a) differential economic benefits and facilities available to the family, and (b) the standards of occupancy and of fitness for habitation of urban dwellings.

Universal Declaration of Human Rights

10 Dec 1948

The Universal Declaration of Human Rights was proclaimed in resolution A/RES/217(III) by the General Assembly in 1948 as a common standard of achievements for all peoples and all nations. It set out, for the first time, fundamental human rights to be universally protected. The Declaration has been translated into over 500 languages.

4th Session of the Social Commission

2 May 1949 - 20 May 1949

The Fourth Session of the Social Commission considered the unified draft of the Convention on Traffic in Persons and the Suppression of Prostitution of Others and requested to convene the International Group of Experts on the Prevention of Crime and the Treatment of Offenders. The Report of the Fourth Session recommended that the United Nations leads in the field of family, youth and child welfare by initiating, in coordination with appropriate organs, a comprehensive programme of work. It also requested the Secretary-General to present a report on the protection against loss of income of the family due to unemployment, sickness, invalidity, old age and death.

5th Session of the Social Commission

5 Dec 1949 - 15 Dec 1949

The Fifth Session of the Social Commission focused on the work programmes in (a) family, youth and child welfare, (b) prevention of crime and treatment of offenders, and (c) housing and town and country planning. It recommended an analysis of necessary community social services in under-developed areas.

The Report of the Fifth Session specified the Commission's primary responsibility in (a) activities of direct assistance to Governments, (b) social services, (c) family, youth and child welfare, (d) welfare of special groups, (e) social defence, (f) housing and town and country planning, and its basic responsibility considering (1) studies regarding standards of living (living conditions), (2) migration, and (3) world social and cultural situations.

3 Apr 1950 - 5 May 1950

The Sixth Session of the Social Commission reviewed advisory social welfare services and considered social assistance to migrants, welfare of older persons, social rehabilitation of persons with physical disabilities, in reference to the Report of the World Social Situation. The Report of the Sixth Session underscored the need to establish international standards for the education, treatment, training and placement of persons with disabilities.

19 Mar 1951 - 13 Apr 1951

The Seventh Session of the Commission recommended the Council to consider (a) training for social work, (b) methods of social welfare administration, (c) use of community welfare centres as effective instruments to promote economic and social progress throughout the world, (d) probation, (e) criminal statistics, (f) assistance to indigent aliens, and (g) recognition and enforcement abroad of maintenance obligations. The Report of the Seventh Session continued the consideration of social rehabilitation of persons with disabilities and underscored the need to draw attention to the problem of adaptation and rehabilitation from an integrated perspective.

12 May 1952 - 29 May 1952

The Eighth Session of the Social Commission considered, as part of its agenda, (a) persons with physical and visual disabilities, (b) family and child welfare, including homeless children, (c) simplification of administrative procedures for migrants, and (d) and housing and town and country planning, including urban land policies. The Report of the Eighth Session further delineated the agreements on the

rehabilitation for persons with physical disabilities, such as (a) a new approach to disability, (b) education of public opinion, (c) a complete rehabilitation programme, (d) developing rehabilitation services, (e) training rehabilitation personnel, (f) organizing and financing rehabilitation services, (g) the contribution of the United Nations, specialized agencies and non-governmental organizations, and (h) methods of coordination.

Report on the World Social Situation (1952)

8 Sep 1952

The 1952 Report on the World Social Situation was the first volume of the series, per the invitation of the General Assembly to draft a general report on the world social and cultural situation (A/RES/280 (III)). As decided at the sixth session of the Social Commission, the scope of the report came to be dedicated on social matters, not on cultural situation (E/CN.5/208). As such, the Report addressed socio-economic questions, such as standards of living, national patterns of income distribution and progress in combating poverty. The following limitations were delineated, that the report (a) not [be] based on new or original research data, (b) report on existing social conditions, but not on governmental (or inter-governmental or non-governmental) programmes to improve those conditions, (c) does not cover the entire field embraced by the word "social," but as the subtitle indicates, considers the world social situation "with special reference to the standards of living." The Report gave special attention to the social conditions in the economically less developed countries and stressed that some of the most urgent problems and needs of the present day are associated with the very process of change and development. The 1952 Report was the first in its special series (1952-1993) and was published with a special reference to the standards of living. The series has aimed to identify emerging social trends and analyze relationships among major developmental issues with international and national dimensions. To date, it serves as a handy, single-volume, succinct summary of global development seen from a social perspective.

The Ninth Session of the Social Commission considered, as agenda items, as agenda items, (a) community welfare centers, (b) strengthening of national programmes for family and child welfare, (c) social defence, (d) financing of housing, and (e) advisory social welfare services. The Report of the Ninth Session further delineated programmes designed for the promotion of services for persons with disabilities, with a focus on restoring their independent and productive role in the society.

The Tenth Session of the Social Commission considered the (a) international definition and measurement of standards and levels of living, (b) principles of community development, (c) training of welfare personnel, (d) financing of housing and community improvement programmes, and (e) international survey of programmes of social development. The Report of the Tenth Session adopted the programme of work to (a) assist the regional secretariats in the consideration of the social aspects of economic development, (b) develop indicators for measuring non-material and other social and technical aspects of levels of living, and (c) provide research and technical assistance in the social field.

The 11th Session of the Social Commission considered the (a) maintenance of family levels of living: social policy relating to social insurance, social assistance and related social services, (b) recommendations of the first United Nations Congress on the Prevention of Crime and the Treatment of Offenders, (c) financing of housing and community improvement programmes, and (d) community development. The Report of the 11th Session adopted the programme of work to (a) assist Governments in strengthening research on problems social policy, and (b) conduct studies in the social field, namely on industrialization, productivity, public administration aspects of community development, housing, building and planning, rehabilitation of persons with disabilities, and social defence.

Report on the World Social Situation (1957)

23 Aug 1957

The 1957 Report on the World Social Situation addressed the problems of people undergoing rapid transition through urbanization and assessed social problems of urbanization in economically underdeveloped areas, with a focus on two regions, sub-Saharan Africa and Latin America. It demonstrated the need for a closer integration of economic and social objectives and much less compartmentalization of thought, and a better understanding of the complex processes of development. The 1957 Report was the second volume of the series.

First United Nations Development Decade (1960-1970)

19 Dec 1961 - 19 Dec 1970

The First United Nations Development Decade (1960-1970) was proclaimed at the 16th Session of the General Assembly on 19 December 1961 (A/RES/1710 (XVI)). The Decade was established with a shared recognition that socio-economic development of less developed countries is not only of primary importance to those countries but is also crucial to the attainment of international peace, security and prosperity. The Report of the Secretary-General expanded the concept of development to encompass the improvement of social conditions and human aspirations as key objectives.

Report on the World Social Situation (1963)

18 Feb 1963

The 1961 Report on the World Social Situation (RWSS) aimed to sum-up the social conditions and social programmes since 1950 and explored, in particular, social problems and trends in the economically less developed regions of Latin America, the Middle East, Asia and Africa. The 1963 Report was the first in the biennial cycle and the fourth volume of the series.

The International Cooperation Year was proclaimed in resolution [(A/RES/1907(XVIII)) by the General Assembly on 21 November 1963. The year 1965, the twentieth year of the United Nations, was designated as the Cooperation Year to increase global co-operation and facilitate the settlement of major international problems.

Report on the World Social Situation (1965)

1 Jul 1965

The 1965 Report on the World Social Situation (RWSS) explored practical methods of promoting social change and introducing new practices of production and consumption at the local level for the purpose of economic and social development. It noted the obstacles to social change and development (at the local level, channels and methods of information and communication, the role of education, traditional values and institutions and new organizational requirements, the role of local government and local leadership, the administrative system and local planning as instruments of change) during the first half and mid-point of the First United Nations Development Decade (1960-1970). The 1965 Report was published with a special reference to popular participation and motivation for development and was the fifth volume of the series.

17th Session of the Social Commission

19 Apr 1966 - 4 May 1966

The 17th Session of the Social Commission, ahead of the change of its name in the following session, considered the reappraisal of the role of the Social Commission, with the Secretariat noting the criticism that the Commission has (a) insufficiently addressed major social development problems, such as social reform, the role of the State in planning for social development, and the social aspects of industrialization, (b) insufficiently emphasized practical programmes and technical co-operation in the developing countries, (c) been too concerned with economic questions and theoretical aspects of social planning at the expense of urgent problems in fields such as social welfare and social defence. The Report of the 17th Session (a) underscored that the research be of a practical nature and action-oriented, and (b) suggested to consider, as priorities, training programmes for national personnel, social aspects of natural resources development and disarmament, social reform and institutional change.

The 18th Session of the Commission for Social Development, previously named the Social Commission, adopted the draft declaration on social development, housing, building and planning, land reform, social questions relating to the extension of health services, and review of technical co-operation activities in social development.

It marked a first instance whereby an international instrument provided clear guidelines, not only for social policies but also for the integration of economic and social action for the improvement of the social environment and the well-being of the individual. The Declaration was proclaimed on 11 December 1969 in resolution A/RES/2542 XXIV of the 24th Session of the General Assembly.

United Nations Decade of Disabled Persons

1 Jan 1983 - 1 Jan 1992

The United Nations Decade of Disabled Persons (1983-1992) was proclaimed at the 37th Session of the General Assembly on 3 December 1982 (A/RES/37/53). The Decade aimed to provide a time frame during which Governments and organizations could implement the activities recommended in the World Programme of Action Concerning Disabled Persons. With regard to education and employment of persons with disabilities, the General Assembly adopted the "Tallinn Guidelines for Action on Human Resources Development in the Field of Disability" in 1989, which provided a framework for promoting participation, training and employment of persons with disabilities within all government ministries and on all levels of national policy-making in order to equalize opportunities for persons with disabilities. The Report of the Secretary-General recommended that disability policies be considered in conjunction with societal changes and emerging issues, such as demographic trends and family structures.

The World's Women 1970-1990 Report

1 May 1991

The World's Women 1970-1990: Trends and Statistics report was published in 1991 as a new type of international statistical publication in response to a rising demand for reliable and comprehensive data on the situation of women. Following the United Nations Decade for Women: Equality, Development, Peace (1976-1985), the report aimed to provide a tool for promoting equality, changing attitudes towards women's work, worth and responsibilities. First in the series of statistical sourcebook presenting country and area data on women, it used innovative techniques and formats to move beyond a linear narrative on women's conditions. The first issue highlighted (a) women, families and households, (b) public life and leadership, (c) education and training, (d) health and child-bearing, (e) housing, human settlements and the environment, and (f) women's work and the economy. The 1990 Report presented a variety of social and human development indicators and milestones of advocacy for women's equity.

The World Summit for Social Development was held in Copenhagen in 1995 to recognize the significance of social development and human well-being. The Summit was the first opportunity for the world community to focus its attention at the highest political level on the nature and roots of social problems and trends. World leaders pledged to make the conquest of poverty, the goal of full employment and the fostering of social integration overriding objectives of development. Governments adopted the Copenhagen Declaration and Programme of Action to represent a new consensus on people-centered development and to advance social development through ten commitments. The Declaration remains as the most comprehensive action plan for the achievement of social development.

The World's Women 1995: Trends and Statistics report was published as an official document of the Fourth World Conference on Women in 1995. Alluding to the Beijing Declaration and Platform for Action, the report aimed to provide information on women's contribution to economic, political and family life and to effect changes in policies that are unfair to women. The second issue highlighted (a) population, households and families, (b) population growth, distribution and environment, (c) health, (d) education and training, (e) work, (f) power and influence. The 1995 Report shed light on the positive link between women's empowerment and sustainable development.

20 Dec 1995

The First United Nations Decade for the Eradication of Poverty (1997-2006) was proclaimed at the 66th Session of the General Assembly on 20 December 1995 (A/RES/50/107) under the theme 'Eradicating Poverty is An Ethical, Social, Political and Economic Imperative of Humankind'. Noting the multidimensionality and complexity of poverty, the First Decade called for strengthened commitment to poverty eradication at the national and international levels, and brought forth special initiatives, such as the World Solidarity Fund, International Year of Microcredit, and International Human Solidarity Day. The Report of the Secretary-General recommended countries to reaffirm their commitment to poverty eradication by establishing a national development strategy and achieving internationally agreed development goals.

The Second International Decade of the World's Indigenous People (2005-2015) was proclaimed at the 59th Session of the General Assembly on 20 December 2004 (A/RES/59/174), under the theme 'Partnership for Action and Dignity'. The Second Decade set forth five objectives, to (1) promote non-discrimination and inclusion of indigenous peoples in processes at all levels, (2) promote the full and effective participation of indigenous peoples in decision making, (3) redefine development policies that are culturally appropriate for indigenous peoples, (4) adopt targeted policies/programs for the development of indigenous peoples, and (5) develop strong monitoring mechanisms to improve the lives of indigenous peoples. The Report of the Secretary General recommended the recognition of indigenous peoples and their forms of governance in order to mainstream their rights and priorities.

The World's Women 2005 Report

1 Aug 2005

The World's Women 2005: Progress in Statistics report uniquely focused on gender-sensitive national statistical systems and sex disaggregated statistics. Reviewing gender concerns over 30 years, it proposed a set of strategies to strengthen national capacity to collect and report statistics, and to improve mainstreaming of gender concerns. The fourth issue highlighted (a) demographics, (b) health, (c) education, (d) work, (e) violence against women, (f) poverty, (g) human rights, and (h) decision-making, of which population, education enrollment and participation in the labor market were found to be relatively well covered by national statistical systems, while information was significantly lacking on violence against women, poverty, births and deaths. The 2005 Report recommended governments to conduct at least one census every 10 years, to establish, strengthen and maintain civil registration and vital statistics systems.

Convention on the Rights of Persons with Disabilities

13 Dec 2006

The Convention on the Rights of Persons with Disabilities and its Optional Protocol (A/RES/61/106) was adopted on 13 December 2006 and entered into force on 3 May 2008. As the first international human rights treaty negotiated with civil society and the first comprehensive human rights treaty of the 21st century, it delineated a broad categorization of persons with disabilities and reaffirmed that all persons with all types of disabilities must enjoy all human rights and fundamental freedoms. The Convention also delineated how all categories of rights apply to persons with disabilities. The Convention is available in various languages, including international and American sign languages.

The 2007 World Youth Report provided a regional overview, distinct from previous reports, summarizing major youth development trends in the fifteen priority areas of the World Programme of Action for Youth, including employment, education, health, poverty and violence. It noted that the ability of youth to contribute to the development of their societies can be constrained not only by lack of capacity among youth, but also by the limited opportunities for participation in development. It identified the absence of an enabling environment for youth development and participation as a common constraint and called for promoting youth participation in areas such as employment, civic engagement, political participation and volunteerism. The 2007 Report was entitled 'Young People's Transition to Adulthood: Progress and Challenges'.

The 2007 Report on the World Social Situation (RWSS) focused on the key role of productive employment and decent work in reducing poverty and promoting social development by surveying global trends in employment. It closely examined jobless growth, global informalization of the labor market, economic and social liberalization and migration. It emphasized that political reforms and legal provisions are necessary to prevent discrimination in society in order to promote productive employment. It pointed to the need to ensure universality of social protection coverage in view of the fact that more workers are in employment situations that are casual, informal and out of standard collective contracts. The 2007 Report was entitled 'The Employment Imperative'.

The 2010 Report was entitled 'Rethinking Poverty'.

It examined youth migrants' experiences during different phases of migration, including preparation, journey and transit, challenges faced in the destination as well as awareness and engagement of young people on migration issues. It noted that young people are crucial stakeholders in the pursuit of successful migration outcomes and that while youth are especially vulnerable to the risks and dangers associated with migration, their capacity as agents of social change and development should not be underestimated. It recommended that an increased commitment among young people, youth-led organizations and greater political will of decision makers at all levels are needed for meaningful youth participation in migration and development policy planning, and that promoting awareness of young people and to enable their full engagement in migration-centered initiatives can facilitate their experience and enable them to assume ownership of their contribution to development. The 2013 Report was entitled 'Youth and Migration'.

The 2013 Report on the World Social Situation built on the 2005 RWSS on inequality and emphasized that addressing inequalities is not only a moral imperative but necessary to unleash the human and productive potential and to bring development towards a socially-sustainable path. To that end, it examined social, economic and spatial inequality trends and highlighted inequalities within and across countries to show the cumulative, mutually-reinforcing effects of inequality on the systematic lack of participation and on the intergenerational transmission of poverty. It also discussed the role of economic and political institutions in promoting participation and empowerment. The 2013 Report was entitled 'Inequality Matters'.

The Third United Nations Decade for the Eradication of Poverty (2018-2027) was proclaimed at the 72nd Session of the General Assembly on 20 December 2017 (A/RES/72/233) under the theme 'Accelerating Global Actions for a World without Poverty'. Placing importance on institutional and policy coherence, a

system-wide plan of action for the Third Decade identified core principles for collaborative inter-agency action. The Report of the Secretary-General recommended implementing joint programming, mainstreaming gender perspectives, and strengthening partnership and cooperation.

System-wide Plan of Action for the Third United Nations Decade for the Eradication of Poverty

19 Jan 2018

The System-wide Plan of Action for the Third United Nations Decade for the Eradication of Poverty (2018-2027) was adopted to address the response of the United Nations System to the theme of the Third Decade, including an inter-agency, system wide plan of action to coordinate the efforts of the United Nations. It contained recommendations concerning how to make the Decade effective in support of the poverty eradication-related internationally agreed development goals, including the Sustainable Development Goals. The Plan of Action is founded on ten basic principles and covers seven thematic policy areas.

World Youth Report (2018)

19 Nov 2018

The 2018 World Youth Report examined the mutually supportive roles of the new agenda and current youth development efforts and how evidence-based youth policies can help accelerate youth-related objectives. It focused primarily on the areas of education and employment, underlining the realization of targets under the Sustainable Development Goals as fundamental to overall youth development. It noted that evidence-based youth policies, tailored and adapted to national and (where possible) local contexts, help ensure that youth development challenges are addressed. It underlined the need to strengthen youth participation mechanisms to facilitate young people's engagement in policies and activities that enhance sustainable development efforts. It suggested that the new development landscape offers innumerable opportunities for young people to thrive, when coupled with existing efforts to advance youth policy development and implementation, both through targeted youth policies and the mainstreaming of youth issues. The 2018 Report was entitled 'Youth and the 2030 Agenda for Sustainable Development'.
