**REMARKS FOR THE CLOSING OF THE 57TH SESSION OF THE
COMMISSION ON POPULATION AND DEVELOPMENT**

It is my pleasure to join you for the closing of the fifty-seventh session of the Commission on Population and Development.

This week, we have come together to celebrate the thirtieth anniversary of the International Conference on Population and Development. The task of this year's anniversary session was threefold:

- To assess what has been achieved in delivering on the promises of the Cairo conference held 30 years ago;
