AFPPD Oral statement for the 47th Session of the Commission on Population & Development

Statement by the Asian Forum of Parliamentarians on Population and Development, a non-governmental organisation in consultative status with the Economic and Social Council

We Asian-Pacific Parliamentarians from the Asian Forum of Parliamentarians on Population and Development make this official AFPPD statement for the 47th Session of the Commission on Population and Development (CPD).

AFPPD welcomes the theme of the 47th Session: Assessment of the status of implementation of the Programme of Action of the International Conference on Population and Development.

Since the adoption of the ICPD PoA in 1994, the Asia-Pacific region has witnessed considerable progress in terms of increasing the availability of sexual and reproductive health services, including family planning, improving maternal health and promoting gender equality. There has been a 50 per cent fall in maternal mortality over the past 20 years and a decrease in HIV infection rates, though HIV prevalence is still increasing, partly due to an expansion of treatment that has increased the survival of persons living with HIV and AIDS².

Despite these advances, challenges remain and new challenges arise. Access to integrated, quality sexual and reproductive health services remains uneven, with women, adolescents, and youth, those of lower socioeconomic status and those living in rural and remote areas being at a considerable disadvantage³. Barriers to accessing sexual and reproductive health information and services, including contraception result in unintended pregnancies, avoidable maternal and child mortality and morbidity, and HIV and other sexually transmitted infections⁴.

We acknowledge and commit to address in our respective parliaments the persistence and pervasiveness of gender-based violence including laws, regulations, policies and practices that discriminate against women and girls; the damage caused by natural disasters and environmental degradation which impact those without SRHR support most severely; the rapid demographic shift particularly ageing in Asia, will require comprehensive social and economic adaptation; and the significant number of migrants, as well as inadequate social protection for most migrants. In addition, there are persistent inequalities in income and opportunity, often associated with such demographic features as age, gender, ethnicity, and race. We acknowledge that without intensive support and advocacy, some member nations in our region will show no major improvement on many of the ICPD PoA areas in the near future.

These challenges have a tangible impact on people's lives, as well as social and economic development in the broader context. They need to be effectively addressed in the post 2015 development agenda if we are to ensure the sustainability of development. Moving forward requires greater attention to sustainability, gender equality and inclusion by ensuring that the concerns of all groups are addressed.
