Draft programme of work of the Population Division, Department of Economic and Social Affairs, for the biennium 2010-2011

Note by the Secretariat

1. The draft programme of work of the Population Division of the Department of Economic and Social Affairs for the biennium 2010-2011, which is contained in the annex to the present note, is submitted for the consideration of the Commission on Population and Development in compliance with the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation (ST/SGB/2000/8).
