The Vienna Café will open from 9 am to 5 pm.


The Media Tent at the North Lawn

TRAVEL OF DELEGATES FROM LDCs



Support for travel of the Head of State and officials from Least Developed Countries (ST/SGB/107/Rev.6)

- A Note Verbale and guidance document sent 3 July, providing information on entitlements and instructions.
- Requests should ideally be received a month before travel date. To date, only 30% of LDC delegations have provided their complete travel requirements for timely processing.
- A dedicated email ldctravel@un.org, was created for the delegations on LDC GA travel-related requirements or queries.
- Delegates who have been issued commercial air tickets by the travel agency are encouraged to download the Amex GBT mobile app <u>IOS/Android</u> which provides up-to-date information on the status of their flights and the ability to quickly connect and chat with a travel counselor via live messenger for support.



DELEGATION PARKING PERMIT APPLICATIONS



Arrangements for obtaining parking permits for the 78th session of the General Assembly

- A guidance Note Verbale sent on 3 July 2023, providing detailed information to facilitate preparations, details of application submission process and requirements (refer to Annex 1 of NV)
- Original application forms should be received ASAP, but no later than 1 September 2023 to avoid delayed issuance
- Two permit types will be issued for each vehicle:
 - A new version of electronic eTag (affixed to front windshield)
 - A decal to be visibly displayed on the vehicle dashboard





Dashboard Decal

- Current, older version parking eTags (stickers) no longer valid from 18 September 2023
- One Ambassador decal will be issued to the Ambassador's vehicle
 - A second Ambassador decal will be issued for Security Council members
 - Ambassador decal allows access through 43rd Street and 1st Avenue at all times, except during HLW





DELEGATION PARKING PERMIT APPLICATIONS



Arrangements for obtaining parking permits for the 78th session of the General Assembly

- All vehicles to be cleared from UNHQ garage for 17 September 2023
 - Updated overhead vehicle scanning systems in affect from 18 September
 - Effective implementation relies on new version eTags affixed to all vehicles prior to entry
- Delegations reminded that inoperable vehicles to be removed from the garage and only vehicles with valid registrations will be issued updated parking permits.
- Current, older version eTags to be returned only when collecting updated permits.
 - Garage Administration will inform when your permits are ready for collection
- Please provide current contact information to ensure Garage Administration can advise on collection of updated permits.
