Tenth meeting

Workshop on the Links between Drug Trafficking and Other forms of Organized Crime: International Coordinated Response

The Chair made a statement.

The Workshop was opened by the Moderator of the Workshop, Professor Jay Albanese, the Wilder School of Government & Public Policy at Virginia Commonwealth University.

Panel I: Drugs and smuggling/trafficking

Presentations were made by the following panellists: Kristiina Kangaspunta, Executive Officer and Head of the Applied Research Programme of the United Nations Interregional Crime and Justice Institute (UNICRI), Matthew Nice, research expert at UNODC Laboratory Science and Statistics and Surveys Sections (UNODC) and Alexander Seger, Head of Economic Crime Division and responsible for the Council of Europe's cooperation programmes against cybercrime, corruption, money laundering and trafficking in human beings (Council of Europe).

Panel II: Drugs and the larger political economy

Presentations were made by the following panellists: Charles Goredema, Communication Consultant, Institute for Security Studies, Crime in Africa Programme (South Africa), Martin Healy, Latin America Coordinator for Counterterrorism, under the Office of the Coordinator for Counterterrorism, U.S. Department of State (USA) and Yvon Dandurand, Senior Associate, International Centre for Criminal Law Reform and Criminal Justice Policy; criminologist at the University of the Fraser Valley, Abbotsford, British Columbia and Associate Vice-President of Research and Graduate Studies (Canada).

Registration and credentials

In accordance with rules 1-3 of the provisional rules of procedure for the Twelfth Congress, the delegation of each State participating in the Congress should consist of a head of delegation and such other representatives, alternate representatives and advisers as may be required. The credentials (full name, title, address, facsimile and e-mail address) of representatives, alternate representatives and advisers, issued by the Head of State or Government or by the Minister for Foreign Affairs, should be submitted to the Executive Secretary of the Congress c/o Ms. Annika Wythes, 4th Floor Left Block.

On-site registration will begin on Friday, 9 April 2010, at 10 a.m., and the desk will remain open until 6 p.m. The registration desk will be open from 8 a.m. to 6 p.m. from 10 to 19 April 2010. For the high-level segment, the registration desk will be open from 8 a.m. to 9 p.m. on 16 and 17 April.

It is strongly recommended that delegations submit to the secretariat the names and photographs, in JPEG format, of ministers or other delegates of similar or higher rank in advance in order to expedite preparation of VIP badges and minimize inconvenience.
