

The Council postponed to a future session the election of one member from Asian States for a three-year term beginning on 1 January 1995.

#### INTERNATIONAL NARCOTICS CONTROL BOARD

The following six members were elected for a five-year term beginning on 2 March 1995:

(a) Five members from among candidates proposed by Governments: Edward A. Babayan (Russian Federation), Mohamed A. Mansour (Egypt), António Lourenço Martins (Portugal), Oskar Schroeder (Germany) and Elba Torres Graterol (Venezuela);

(b) One member from among candidates proposed by the World Health Organization: Elisaldo Luiz de Araújo Carlini (Brazil).

#### EXECUTIVE COMMITTEE OF THE PROGRAMME OF THE UNITED NATIONS HIGH COMMISSIONER FOR REFUGEES

Pursuant to General Assembly resolution 48/115 of 20 December 1993, the Council elected SPAIN as a member of the Executive Committee, thereby increasing the membership from forty-six to forty-seven.

#### COMMITTEE OF EXPERTS ON THE TRANSPORT OF DANGEROUS GOODS

Pursuant to its resolution 1986/66 of 23 July 1986, the Council endorsed the applications of the following States for full membership in the Committee: ARGENTINA, BELGIUM, BRAZIL, MEXICO and MOROCCO.

#### COMMITTEE FOR PROGRAMME AND COORDINATION

The Council, in accordance with its resolution 2008 (LX) of 14 May 1976 and General Assembly decision 42/450 of 17 December 1987, nominated the following seven States for election by the General Assembly at its forty-ninth session for a three-year term beginning 1 January 1995:

(a) *African States* (two vacancies): BENIN and GHANA;

(b) *Eastern European States* (one vacancy): RUSSIAN FEDERATION;

(c) *Latin American and Caribbean States* (two vacancies): BAHAMAS and MEXICO;

(d) *Western European and other States* (two vacancies): FRANCE and UNITED STATES OF AMERICA.

#### WORLD FOOD COUNCIL

The Council, in accordance with General Assembly resolution 3348 (XXIX) of 17 December 1974, nominated the following seven States for election by the General Assembly at its forty-ninth session for a three-year term beginning on 1 January 1995:

(a) *African States* (three vacancies): ANGOLA, KENYA and UGANDA;

(b) *Asian States* (two vacancies): INDONESIA;

(c) *Eastern European States* (two vacancies): RUSSIAN FEDERATION;

(d) *Latin American and Caribbean States* (three vacancies): COLOMBIA and HONDURAS.

The Council postponed to a future session the nomination of one member from Asian States, one member from Eastern European States, one member from Latin American and Caribbean States and two members from Western European and other States for a three-year term beginning on 1 January 1995.

The Council further postponed the nomination of one member from Eastern European States and one member from Western European and other States whose election had been postponed by the General Assembly at its forty-eighth session.
