BACKGROUND INFORMATION

At the United Nations Conference on Sustainable Development (Rio+20) Governments reaffirmed the critical importance of shifting towards sustainable consumption and production (SCP) patterns, as an overarching objective of and prerequisite for sustainable development. At Rio+20 governments also formally adopted the Ten Year Framework of Programmes on Sustainable Consumption and Production Patterns (the “10YFP”), providing the global platform for international cooperation to accelerate the shift towards SCP in both developed and developing countries. This *global* platform will deliver support for the shift to SCP at *national and regional* levels.

The 10YFP focuses on the development, replication and scaling up of SCP and resource efficiency initiatives. It supports capacity building, and facilitates access to technical and financial assistance for developing countries. The aim is to contribute to decoupling environmental degradation and resource use from economic growth, and thus to increase the net contribution of economic activities to poverty eradication and sustainable development. Building on what has been achieved in the past, including through the Marrakech Process on SCP, activities under the 10YFP, at all levels (global, regional and national) will help to put the world on a path towards SCP patterns, engaging the broad range of stakeholders relevant to jointly achieving this goal.

While UNEP has been requested to serve as the 10YFP Secretariat, the UN General Assembly, at its 67th session, designated the Economic and Social Council ([ECOSOC](#)) as the interim reporting body of the 10YFP (RES 67/203). The [Substantive Session of the ECOSOC in July 2013](#) - one year after the formal adoption of the 10YFP - will offer a unique occasion to report on progress and ongoing implementation of the 10YFP, as well as to discuss the challenges and opportunities for delivering transformative change towards sustainable consumption and production patterns.

OBJECTIVES OF THE PANEL

This Panel Discussion, organized by the Secretariat of the 10YFP, will have four main objectives that will structure the presentations and discussions:
