SPEAKERS BIOGRAPHICAL NOTE

Adrian OTTEN, is Director of the Intellectual Property Division of the Secretariat of the World Trade Organization (WTO), the responsibilities of which include intellectual property, competition policy and government procurement. Mr. Otten is a graduate of the University of Cambridge, England. After posts with the Commonwealth Secretariat in London, working on international trade questions, and with the Swaziland Government in Brussels, assisting them in their negotiations with the EEC in the context of the first Lomé Convention, he joined the GATT Secretariat in 1975. He held a variety of posts within the GATT Secretariat. Between 1986 and 1993, he was Secretary of the Uruguay Round Negotiating Group on Trade-Related Aspects of Intellectual Property Rights.

Nuno PIRES DE CARVALHO is Acting Director-Advisor, Industrial Property Legislation for Development, Economic Development Sector, World Intellectual Property Organization (WIPO). His most recent post before joining WIPO, was as Counselor, from 1996 to 1999, at the Intellectual Property Division of the World Trade Organization (WTO).

Mr. Pires de Carvalho obtained an LL.B from the Federal University of Minas Gerais, Brazil and was admitted to Brazil's Bar in 1981; a Master of Law & Economics (LL.M.) and Doctorate in Law & Economics (S.J.D.), Federal University of Minas Gerais, Brazil; a Master of Laws (LL.M.) and Doctorate in Legal Sciences (S.J.D.), Washington University in St. Louis, MO, USA, at which he was also a visiting adjunct professor at the Law School (1995-1996); and a Master of Laws (LL.M.), Catholic University of Lisbon, Portugal.

He is the author of many publications, the most recent of which is "The TRIPS Regime of Patent Rights", 2nd edition, Kluwer Law International, London, 2005; and writes articles on industrial property law, including "From the Shaman's Hut to the Patent Office: In Search Of a TRIPS-Consistent Requirement to Disclose the Origin of Genetic Resources and Prior Informed Consent", 17 Wash. U. J.L. & Policy 111 (2005); "The Problem of Gene Patents", 3 Wash. U. J. Global Stud. 701 (2004); "The Primary Function of Patents", 1 U. Ill. J.L. Tech. & Policy 25 (2001); "Requiring Disclosure of the Origin of Genetic Resources and Prior Informed Consent Without Infringing the TRIPS Agreement: The Problem and the Solution", 2 Wash. U. J.L. & Policy 371 (2000); and "From the Shaman's Hut to the Patent Office: How Long and Winding is the Road?", 41 Rev. ABPI 3 (Jul/Aug 1999).

Simonetta ZARRILLI is a Legal Officer in the Division on International Trade and Commodities of the United Nations Conference on Trade and Development (UNCTAD) Secretariat. She joined UNCTAD in 1988 and since then she has been working on a number of trade and development related issues - such as preferential tariff treatments for developing countries, trade and environment, standards and regulations, trade in services, intellectual property rights, agro-biotechnology, the interface between energy, trade and development, and non-trade concerns in international trade. She has carried out a number of analytical, intergovernmental and technical cooperation activities in the abovementioned areas.

Ms. Zarrilli has produced a large number of publications, including books, official UNCTAD papers, studies and essays. In particular, she is the editor of the following books: Energy and Environmental Services: Negotiating Objectives and Development Priorities (published in 2003 by UNCTAD); Trade Agreements, Petroleum and Energy Policies (published in 2000 by UNCTAD), Trade in Health Services: A development perspective (jointly published in 1998 by UNCTAD and the WHO), Eco-labelling and International Trade (published in 1997 by MacMillan). She has just published a study entitled: International Trade in GMOs and GM Products: National and Multilateral Legal Frameworks (published in the UNCTAD study series: Policy Issues in International Trade and Commodities).

Since November 2003, she has been acting as associate editor of OGEL (Oil, Gas & Energy Law Intelligence), and since March 2002, she has joined the trade law research group at the University of Dundee, UK, as research associate. In March 1985 she was admitted to the Italian Bar. Ms. Zarrilli holds a LLM. Degree from the College of Europe, Bruges, Belgium and a B.A. degree from the University of Siena, Italy. She is fluent in English, French, Spanish, Portuguese and Italian.
