a/ In accordance with their announced policies, the Governments of the Byelorussian Soviet Socialist Republic, the Ukrainian Soviet Socialist Republic and the Union of Soviet Socialist Republics have additionally made available for United Nations account during the period 1 January to 19 September 1972 the equivalent of \$34,540, \$129,180 and \$979,554, respectively, in their national currencies in respect of their assessed share of the appropriations for technical assistance as provided for in Part V of the United Nations regular budget for 1971.
