Mr. Chairman,

I have the honour to speak on behalf of the Member States of the European Union.

The Candidate Countries Turkey, the former Yugoslav Republic of Macedonia^{1*}, Montenegro^{*}, Serbia^{*} and Albania^{*}, the country of the Stabilisation and Association Process and potential candidate Bosnia and Herzegovina, as well as Ukraine, the Republic of Moldova, Armenia and Georgia, align themselves with this statement.

As both report presenters have noted, this year marks the 20th anniversary of the Office of Internal Oversight Services. We would like to thank the OIOS for its work over these two decades, and to emphasize once again the strong and longstanding support of the Member States of the European Union for the efforts carried out by the Office.
