STATEMENT ON BEHALF OF THE PERMANENT MISSION OF BOTSWANA TO THE UNITED NATIONS BY FIRST SECRETARY KATLEGO BOASE MMALANE DURING THE CLOSING SESSION OF THE MAIN PART OF THE SEVENTY-FIFTH SESSION OF THE FIFTH COMMITTEE OF THE UNGA

(New York, 30 DECEMBER 2020)

Mr. Chair,

- **1.** I have the honour to speak on behalf of the Permanent Mission of the Republic of Botswana to the United Nations at this closing session of the main part of the seventy-fifth session of the Fifth Committee.

 - Approval of the Regular Budget's \$3.2 billion as a whole;
 - Budgeting of Special Political Missions
 - Financing of PKO's most specifically UNAMID
 - The United Nations Pension Fund
 - Pattern of conferences
 - The United Nations Common system
 - Administration of Justice

Mr. Chair,

- **6.** As a delegation, under the Ambit of the Group of 77 and China and the African Group Botswana places greater interest in protecting the development Pillar in all its aspects including the budget of, OHRLLS, UNCTAD, UN-Habitat, and Regional Economic Commissions.
- 7. My delegation also places great interest in seeing the UN and its regional and sub-regional entities engage in partnerships on the most pressing Peace and security issues especially in the African continent. It only makes sense for the UN to work hand in hand with these Organisations to avoid duplication of efforts, but maximize on the gains.
- 8. In conclusion, Mr. Chair, Let me take the opportunity to congratulate you and the Bureau once again. It is, by and large, your able stewardship during this uniquely challenging session that led us here, as a Member of your Bureau, be quiet assured Botswana shall remain steadfast in supporting the greater cause of this August body.
