We commend the progress achieved so far and we believe that these reforms will lead to a better and more responsive Organisation.

We will comment on specific items upon their introduction, but allow me to highlight two reform areas that are of particular importance to the European Union.

- 1. We remain staunch supporters of more modern and more effective human resource policies at the UN and believe the Secretary-General should use the full extent of his prerogative under the UN Charter in this regard. We have yet to reach an agreement on the HRM package, which now includes a significant number of reports deferred from past sessions. This session offers us for the first time the opportunity to focus on items pertaining predominantly to HRM. We will strive to find consensus and to agree on the principles of Human Resources Management reform to meet the current and future needs of both the Organisation and its staff.
- 2. Conversely, we also welcome the opportunity to continue the work towards a stronger and more robust accountability framework. We see this as a cornerstone of Management Reform, and an integral part of the new Delegation of Authority. The Department of Management Strategy, Policy and Compliance plays a key role in ensuring more accountability and we believe that the Organisation needs to continue fostering a culture of ethics and transparency, in order to prevent and address any type of misconduct. In this regard, we welcome the Secretary-General's reports on the progress achieved so far.

In any case, all EU Member States will work with you in a spirit of constructive cooperation, consensus and collegiality.
