### **Implementation of the Declaration of Commitment on HIV/AIDS and the Political Declaration on HIV/AIDS**

The General Assembly,

*Guided* by the Declaration of Commitment on HIV/AIDS<sup>1</sup> and the Political Declaration on HIV/AIDS<sup>2</sup>, and *noting* the significance of the comprehensive HIV/AIDS review in 2011, as mandated by the Political Declaration on HIV/AIDS, decides to:

- (a) *Welcome* the report of the Secretary-General on progress towards implementation of the Declaration of Commitment on HIV/AIDS and the Political Declaration on HIV/AIDS<sup>3</sup>, and the recommendations contained therein, as an input for consideration in preparations for the High-level plenary meeting in September 2010;
- (b) Undertake necessary consultations to determine during its 65<sup>th</sup> session, but no later than December 2010, the modalities and organisational arrangements for the comprehensive HIV/AIDS review in 2011;
- (c) *Include* in the provisional agenda of its sixty-fifth session the item entitled “Implementation of the Declaration of Commitment on HIV/AIDS and the Political Declaration on HIV/AIDS”.
