Excellency,

I refer to the High-level Dialogue on International Migration and Development, to be held on Thursday, 3 and Friday, 4 October 2013, in accordance with General Assembly resolution 67/219 of 21 December 2012.

Further to the information contained in the Note by the Secretary-General (A/68/162), I propose that, in addition to myself, the President of the Economic and Social Council and the Secretary-General, the following persons make statements at beginning of the morning plenary meeting on Thursday, 3 October: Minister Tobias Billström, Swedish Chairmanship of the Global Forum on Migration and Development; Mr. Ian Goldin, Professor at the University of Oxford, as an eminent person in the field of international migration and development; and Mr. Gibril Faal, Chairman of the African Foundation for Development (AFFORD), as a migrant representative.
