## L. 69 Group Inputs on Framework Document ( inputs of the L. 69 Group are in red below)

Issuas of categories of membership; the question of the veto; regional representation; size of an enlarged Securrity Council and working methods of the Council; and the relationship between the Council and the General Assembly.
a) Categories of membership:

- Pemanent members - a total of 11 seats
- The Republic of China (Peoplers Republic of China), France, The Union of Sorlet Socialist Republics (The Russian Federation), The United Kingdom of Great Britain and Northern Ireland, The United States of America.
- (2 from Africa) (2 from Asia) (1 fram GridxC) (1 from WEOG)
- [In the event of possible expansion, description of an election process for new seats..\}:

Upar adoption of the framework resolution on UNSC reforms by the General Assembly, meriber states desiring to assume pemanent membership shall summit their candidatures in writing to the President of the General Assemily. The General Assembly will then proceed, at a date to be detarmined by the PGA, for the election of new permanent menters of the Security Comimeil, by a vote of two thirds of the menbers of the General Assenbly through a secret bailot. As per established practice, the rules of procechune of the General Assembly will be applied to the election of the new permanent memibers.

- While electing new permanent menbers, the General Assembly would also consider the criteria of Article 23 (I) to the election of the new permanent menbers: "chae regard shall be paid, in the first instance to their contributions to the maintenance of international pence and security and to the other purposes of the Ozganization, and also to equitahle geographical distribnation".
- Non-permanent members with a two-year term - a total of 16
-The election process for non-pemanent two-year term seats will remain unchanged.
b) Regional representation:

That additional seats be elected by the General Assembly as follows:
(a) Two permanent seats and two non-permanent seats for African States;
(b) Two permanent seats and one non-permanent seat for AsiaPacific States;
(c) One non-permenent seat for Eastern European States;
(d) One permanent saat and one non-permanent seat for Latin American and Caribbean States;
(e) One permanent seat for Western European and other States;
(f) One non-permanent seat for Small Island Developing States (SIDS) across all regions

Regional groups shall coordinate to ensure that there is regriar representation for small developing states in the non-permanent category,
c) (i) The size of an enlarged Security Council- a total of 27 seats Whorking methods of the Council:

- The affimative vote of 15 out of 27 menbers of the Security Council will be required for a decision.
- To make meatings of the Council transparent and inclusive, the existing practice to hold closed meatings with no records will be abolished, and access will be given to non-menbers to the Comcil's documantation and records.
- The Conncil will amend its procedures so that items do not remain an its agenda pemanently/beyond ( $x$ ) years.
- Articles 31 and 32 of the Charter mist be fully implenented by consulting with merber states which are not meribers of the Security Council on a regular basis, especially members with special interest in the substantive matter under consideration by the Council.
- Non-manibers should be given spstangtic acoess to subsidiazy bodies of the IRSSC, including the right to participate in debates.
- There should be full and complete participation by elected meubers in penholding resolutions.
- Consultation with and participation of Trocp and Police Contributing Countries in decision making concerning peacekeeping operations must be made mandatory (as laid down in Article 44) and these discussions should be comprehensive covering the
establistmant, conchict, review and termination of peacekeeping operations, including the extension ard charge of manctates, as well as for specific operaticnal issues.
- Countries having specific interest in particular agenda iten must be invited to participate in cornaltations before an outcone document on that item is adopted.
- The council should focus its time and efforts on dealirgy with issues concerning its primary responsibility of maintaining international peace and secuxity as mandated by the UN Charter, rather than encroaching upon the mandate of the General Assentaly - Before mandating measures under Chapter VII of the Charter, the Coumcil should ensure that all efforts for the pacific settlement of disputes through measures urrer Chapter VI have been exhausted, In this regard, the Council must improve its cocperation with regional organisations, particularly the African Union. Surn cooperation must be serious arxd include providing assistance for AU's capacity building as per thair requiremant.
- The Security Courcil should ensure that non-permanent menibers of the Security Council hold the Presidency of the Council at least crice churing their tenure.
d) The question of the veto:
- The veto should be abolished. So long as it exists, it should be extended to all new members of the permanent category of the Security Council, who must enjoy all the prerogatives and privileges of permanent membership in the permanent category including the right of the veto.
e) Relationship between the Council and the General Assembly:
- The expanded Security Council would be encouraged to, inter alia, hold regulax consultations with the General Assembly under its President;
- The Council should submit an analytical, substantive and comprehensive evaluation of the Council's work in its annual report to the General Assembly;
- The Council should submit special reports more Erequently to the General Assembly in accordance with Article 24 (3) of the Charter
f) Any other related matters:

Following the elections of the new permanent members, to accordingly amend the Charter of the UN no later than twelve weeks from the adoption of the Eramework resolution on UNSC reforms,
