Mr. Chairman,

I have the honour and great pleasure to introduce the report of the 2014 session of the Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization, contained in Supplement No. 33 (A/69/33).

The Special Committee met in New York from 18 to 26 February 2014 and continued its deliberations on the questions mandated by General Assembly resolution 68/115. It may be recalled that in operative paragraph 3 of the resolution, the Committee was requested:

- "(a) To continue its consideration of all proposals concerning the question of the maintenance of international peace and security in all its aspects in order to strengthen the role of the United Nations and, in this context, to consider other proposals relating to the maintenance of international peace and security already submitted or which may be submitted to the Special Committee at its session in 2014;
- (b) To continue to consider, in an appropriate, substantive manner and framework, including the frequency of its consideration, the question of the implementation of the provisions of the Charter related to assistance to third States affected by the application of sanctions under Chapter VII of the Charter based on all of the related reports of the Secretary-General and the proposals submitted on the question;
- (c) To keep on its agenda the question of the peaceful settlement of disputes between States;
- (d) To consider, as appropriate, any proposal referred to it by the General Assembly in the implementation of the decisions of the high-level plenary meeting of the sixtieth session of the General Assembly in September 2005 that concern the Charter and any amendments thereto;
- (e) To continue to consider, on a priority basis, ways and means of improving its working methods and enhancing its efficiency and utilization of resources with a view to identifying widely acceptable measures for future implementation;"

Mr. Chairman,

Allow me now to take you through the Report, which consists of five chapters. The first of these chapters is entirely procedural. Paragraphs 11 to 13 list all items and proposals that were under consideration by the Special Committee.

Chapter II, relating to the maintenance of international peace and security, contains several items considered by the Committee.

Pursuant to the request of the General Assembly, the Special Committee considered the question of the **implementation of the provisions of the Charter relating to assistance to third**States affected by the application of sanctions. Paragraphs 15 to 25 of the Report, contained in Section A of Chapter II, reflect the work of the Special Committee on this question.

The summary of the consideration of the revised proposal by Libya with a view to strengthening the role of the United Nations in the maintenance of international peace and security is dealt with in Section B of Chapter II, at paragraphs 26 to 27.

The next section of Chapter II, Section C, spanning from paragraph 28 to paragraph 32, deals with the summary of the discussion on the further revised working paper submitted by the Bolivarian Republic of Venezuela, entitled "Open-ended working group to study the proper implementation of the Charter of the United Nations with respect to the functional relationship of its organs".

Section D of Chapter II of the Report, in paragraphs 33 to 39, summarizes the discussion on the revised working paper submitted by Belarus and the Russian Federation concerning a **request for an advisory opinion of the International Court of Justice** as to the legal consequences of the resort to the use of force by States without prior authorization by the Security Council, except in the exercise of the right to self-defence. The text of a further revised working paper presented by the Russian Federation, also on behalf of Belarus, at the 3rd meeting of the Working Group of the Whole is reproduced in paragraph 37.

The final section of Chapter II of the Report, Section E, in paragraphs 40 to 43, reflects the work of the Special Committee on the working paper submitted by Cuba on **the strengthening of the role of the Organization and enhancing its effectiveness: adoption of recommendations.**

Mr. Chairman,

The item entitled "**Peaceful settlement of disputes**" is set out in Chapter III of the Report in paragraphs 44 to 53. In addition to a general exchange of views, summarized in paragraphs 44 to 47, discussions on the proposals introduced by the Russian Federation to establish a website dedicated to the peaceful settlement of disputes between States and to prepare an update of the 1992 *Handbook on the Peaceful Settlement of Disputes between States*, are summarized in paragraphs 48 to 53.

The discussions on the Repertory of Practice of United Nations Organs and the Repertoire of the Practice of the Security Council by the Committee are summarized in Chapter IV of the Report in paragraphs 54 to 63. It should be noted that the Committee was briefed by the Secretariat on the status of the Repertory of Practice of United Nations Organs and the Repertoire of the Practice of the Security Council. The recommendations on this item that were agreed upon by the Special Committee are set out in paragraph 64 of the Report.

Finally, Chapter V of the Report concerns the consideration of the remaining items on the agenda of the Special Committee. Section A, paragraphs 65 to 73, reflects a summary of the discussion on the **working methods of the Special Committee**. Section B, paragraphs 74 to 78, summarizes the views expressed on the **identification of new subjects**.

Paragraph 78 of Section B, concerning the identification of new subjects, reflects a summary of the views expressed in connection with the proposals by Ghana for the inclusion of a new item, presented in 2010, entitled, "Principles and practical measures/mechanisms for strengthening and ensuring more effective cooperation between the United Nations and regional organizations on the matters relating to maintenance of international peace and security in areas of conflict prevention and resolution and post-conflict peacebuilding and peacekeeping, consistent with Chapter VIII of the Charter of the United Nations".
