The High Level Review of UN Sanctions (HLR), launched at the United Nations May 2014, is an initiative, sponsored by our five governments and organized by the Watson Institute for International and Public Affairs at Brown University and Compliance and Capacity Skills International, LLC. Its purpose is to enhance the implementation of UN sanctions as an instrument to better address threats to international peace and security through improved integration with today's network of internal and external institutions and related instruments.

HLR working groups examined the relationship between actors and institutions within the UN system, coordination with external institutions and instruments, and the roles of regional groups and humanitarian organizations, and ways to respond to emerging challenges. Consulting broadly to assess current sanctions practices and to provide policy-oriented options to enhance sanctions implementation, the HLR developed the Compendium as the combined outcome of deliberations with 150 recommendations to enhance UN sanctions implementation across the broad range of actors. Participants will discuss the HLR's findings and recommendations and address ways in which the suggestions might be taken forward.
