The interactive dialogue aims to provide a platform for an informal exchange and discussions between Members of the ILC and the 6<sup>th</sup> Committee, including visiting Legal Advisers from capitals. Members of the audience are encouraged to ask questions and make comments on the work of the ILC.

This year discussions will focus on the following topics:

### **Crimes against humanity:**

Last year, the Commission concluded its first reading of the set of 15 draft articles and commentaries thereto and invited comments by 1 December 2018. In 2019 the Commission will consider the draft articles in a second reading with a view to concluding its work on the topic.

### **Peremptory norms of general international law (jus cogens):**

The Commission had before it the third report of the Special Rapporteur, which considered the consequences and legal effects of peremptory norms of general international (jus cogens). The Drafting Committee presented interim reports on its deliberations.

### **Identification of Customary International Law:**

This year, the ILC adopted a set of 16 draft conclusions together with commentaries thereto and recommended that the General Assembly, *inter alia*, take note of the draft conclusions and of the Secretariat memorandum on ways and means for making the evidence of customary international law more readily available in a resolution. The Sixth Committee will consider such a resolution at its current session.

### **Looking to the future:**

Following the fruitful exchanges in the context of the 70<sup>th</sup> anniversary, it would appear to be timely to continue discussion and reflection on

- possible future topics which Member States may find useful for the ILC to address,
- topics on the long-term programme of work,<sup>1</sup>
- how the work of the ILC is received and followed-up on by the 6th Committee.
