Mr/Madam Chair,

Slovenia aligns itself with the statement delivered by the European Union and would like to make some additional remarks in a national capacity.

The digital divide, a lack of resources, and the inefficiencies in legal systems can be significant barriers to justice. In today's interconnected world, technology offers us a remarkable opportunity to bridge these gaps and advance access to justice for all.

Slovenia believes that harnessing the power of technology is not only essential but also inevitable in our quest to build more inclusive and just societies.

The deployment of digital platforms and technologies can significantly enhance the efficiency and accessibility of the justice system. Technology can also be a powerful tool for promoting legal education and literacy among the population. Remote legal services can make legal assistance available to underserved and remote areas, ensuring that no one is left behind. However, while we acknowledge the transformative potential of technology, we must also be mindful of its challenges. To ensure that technology benefits all, we must work

collectively to bridge the existing digital divide, which remains a significant issue. With the increased use of technology, we must also be vigilant about protecting the privacy and security of individuals' data by putting in place strong legal frameworks and enhancing international cooperation.
