Delegations will have the option to inscribe to speak in the general debate (10 minutes for individual delegations and 12 minutes for groups) *OR* to inscribe to speak in the general discussions of individual items or clusters in accordance with the traditional sequence held before the 80th session (3 minutes for individual delegations and 4 minutes for groups). Delegations or groups opting to deliver a statement in the general debate would not be able to inscribe in the individual general discussions lists. The general debate and the general discussions of individual items or clusters, each with its own pre-determined list of speakers, will take place consecutively, starting with the general debate, followed by the general discussion on item 24 (a,b,c), and so forth ending with the general discussion of item 65 (Report of the HRC), pursuant to the traditional sequence
