2020-1414	Gudrun Fosse against Secretary-General of the United Nations (<i>Revision</i>)	The application for revision of Judgment is dismissed.
2020-1416	Diane Fairweather against Secretary-General of the United Nations (<i>Interpretation and Revision</i>)	The applications for interpretation and revision of Judgment are dismissed.
2020-1424	Applicant against Secretary-General of the United Nations (<i>Revision</i>)	The application for revision of Judgment is granted in part, to the limited extent of deleting the reference of Deputy Director, ID/OIOS, as the applicant's First Reporting Officer. The remainder of the application is dismissed.
2020-1428	Secretary-General of the United Nations against Alex Lucchini	The appeal of the Secretary-General is dismissed. The cross-appeal is upheld to the limited extent that the order of the UNDT is modified by an order rescinding the contested decision and setting an amount of compensation (<i>in lieu</i>) equivalent to two years' net base salary.
