Introduction

1. The Applicant, a former Special Advisor to the Executive Director at the

United Nations Office for Project Services ("UNOPS") in Copenhagen, challenges

his separation from service in two separate applications:

a. By application filed on 14 April 2024 and registered under Case

No. UNDT/GVA/2024/029/T, the Applicant contests the decision to

constructively dismiss him following his reassignment to a new position that

was abolished after one year of service; and

b. By application filed on 15 August 2024 and registered under Case

No. UNDT/GVA/2024/035, the Applicant contests the decision not to renew

his fixed term appointment ("FTA") beyond 30 June 2024 following the

abolishment of the post he encumbered.

Consideration

2. By Order No. 37 (GVA/2025), the Three-Judge Panel decided to invite the

parties to a Case Management Discussion ("CMD"), which took place virtually via

MS Teams on 12 June 2025.

3. During the CMD, the Three-Judge Panel, *inter alia*, instructed the parties to

confirm their availability and that of their witnesses to attend a virtual hearing on

the merits in the upcoming weeks.

4. To avoid any schedule conflicts during summer holidays, the Tribunal

instructs the parties to confirm their availability, and that of their witnesses, to

attend a virtual hearing on the merits between 17 July and 13 August 2025.
