Introduction

1. On 17 September 2025, the Applicant, a staff member of the Office of the

High Commissioner for Refugees ("UNHCR"), filed an application contesting the

decision to place him on Special Leave Without Pay ("SLWOP").

2. On 19 September 2025, the application was served on the Respondent, and

he was directed to file a reply by 20 October 2025.

3. On 17 October 2025, the parties filed a joint motion advising the Tribunal

that they are engaging in informal discussions to explore the possibility of an

information resolution of the dispute and requested that the proceedings be

suspended for this purpose until 10 November 2025.

Consideration

4. Pursuant to art. 10.1 of the Dispute Tribunal's Statute, the Tribunal shall

suspend the proceedings at the parties' request.

5. The Tribunal notes that the General Assembly has consistently encouraged

alternative dispute resolution. The Tribunal commends the parties for agreeing to

engage in settlement discussions and urges them to consult and deliberate in good

faith towards having this matter resolved amicably.

Conclusion

6. In view of the foregoing, it is ORDERED THAT:

a. The proceedings before the Tribunal in this matter are suspended until

Monday, 10 November 2025, for the purpose of allowing the parties to

engage in informal settlement discussions;

b. If a settlement agreement is reached within this period, the parties shall

inform the Tribunal accordingly without delay, and the Applicant shall

confirm to the Tribunal, in writing, that his application in the present case is

withdrawn; and

c. If no settlement agreement can be reached within the prescribed period, the parties shall inform the Tribunal, which will resume proceedings in the matter, unless otherwise requested and decided. In which case, the Respondent shall file his reply by **Monday**, **24 November 2025**.
