Introduction

1. By a submission filed on 11 April 2025, the Applicant requested the admission

of additional evidence in the form of testimony from Mr. Jason al Hashem, a current

security officer at Economic and Social Commission for West Asia ("ESCWA")

formerly under the direct supervision of Mr. Said Jannoun, the former Chief of Security

and Safety Section at ESCWA.

2. The Respondent did not file any response to the Applicant's request. Since

Practice Direction No.5 requires that any response be filed within five working days,

the motion is deemed to be unopposed.

Consideration

3. The Tribunal notes that, in support of his request, the Applicant submits that

given the direct relevance of al Hashem's evidence to the issues under review by

the Tribunal, the Applicant respectfully requests that Mr. al Hashem's testimony be

admitted into the proceedings, either in the form of a written statement, or an oral

hearing, during which he may present his account and be questioned as appropriate.

4. The Tribunal also observes that the Applicant is prepared to facilitate the

submission of a formal witness statement from Mr. al Hashem.

5. Mr. al Hashem's evidence seems to be relevant to the issues under

consideration and will assist the Tribunal in the determination of the case.

Accordingly, the Applicant's request should be granted.

6. The Applicant should file a written witness statement to further clarify the

proposed evidence. Then the Respondent may determine if the written statement is

acceptable or whether live testimony subject to cross-examination is more

appropriate.

7. In view of the foregoing, it is ORDERED THAT:
