## **Introduction**

1. The Applicant is a Senior Donor Relations Officer at the United Nations High Commissioner for Refugees office in Ethiopia. He holds an indefinite appointment at the P-4 level and is based in Addis Ababa.

## **Procedural History**

2. On 15 April 2025, he filed an application with the United Nations Dispute Tribunal to challenge the Respondent's decision to not select him for Position No. 33010691 (P-4 Senior Emergency Fundraising Officer, Division of External Relations (DER), Director's Office, UNHCR Headquarters in Geneva).

3. The Respondent was directed to file his reply by 6 June 2025.

4. On 3 June 2025, the Tribunal issued Order No. 074 (NBI/2025) granting the parties' motion for suspension of proceedings. The Tribunal suspended the proceedings, including the deadline for the filing of the Respondent's reply, through 7 July 2025.

5. On 25 June 2025, the parties filed a joint motion for that timeline to be extended to 28 July 2025. Order No. 074 (NBI/2025) issued on 26 July 2025, refusing the extension of time, directing the Respondent to file his reply by the existing deadline, and encouraging the parties to continue their settlement discussions. The Respondent filed his reply on 7 July 2025.

6. On 14 August 2025, the Applicant moved to withdraw proceedings as the dispute has been settled *inter partes*.

## **Consideration**

7. The Tribunal commends the parties for their sustained efforts at resolving this dispute amicably.
