Introduction

1. By application filed on 12 June 2025, the Applicant, a former Administrative Assistant with the United Nations Mission in South Sudan, filed an application challenging a 12 May 2025 decision to impose upon him the disciplinary sanction of separation from service for misconduct, and to place his name in ClearCheck.

- 2. The Respondent filed a reply on 18 July 2025.
- 3. The Applicant filed a rejoinder on 11 August 2025.
- 4. In response to Order No. 159 (NBI/2025), on 25 September 2025, the Applicant filed submissions seeking to produce oral evidence at an oral hearing before the Tribunal.
- 5. On 2 October 2025, the Respondent filed a motion for leave to respond to the Applicant's submissions on oral evidence. By Order No. 180 (NBI/2025), the Respondent's motion was granted.
- 6. Further, on 8 October 2025, the Respondent filed submissions in response to Order No. 180 (NBI/2025), objecting to the Applicant's request for oral hearing.

Consideration

- 7. In view of the submissions by the parties, the Tribunal has decided to hold a CMD. The purpose of the CMD is to:
 - a. discuss and identify the claims and issues in the case;
 - b. discuss matters relating to oral hearing; and
 - c. generally deal with any other matter relating to the consideration and determination of this application.
