Introduction

1. By application filed on 12 June 2025, the Applicant, a former Administrative Assistant with the United Nations Mission in South Sudan, filed an application challenging a 12 May 2025 decision to impose upon him the disciplinary sanction of separation from service for misconduct, and to place his name in ClearCheck.

- 2. The Respondent filed a reply on 18 July 2025.
- 3. The Tribunal held a case management discussion ("CMD") on 15 October 2025.

Consideration

- 4. At the CMD, the following matters were discussed:
 - a. Applicant's proposed witnesses;
 - b. Interpretation requirements;
 - c. Duration of the witnesses' testimony;
 - d. Hearing date;
 - e. Mode of hearing; and
 - f. Filing of closing submissions.

Conclusion

- 5. In view of the foregoing, it is ORDERED THAT:
 - a. Only two witnesses will testify, namely the Applicant and Mr. Haim. I.
 - P. Riani.
 - b. The Tribunal will provide Arabic interpretation services for Mr. Riani.
 - c. Mr. Riani will use not more than 30 minutes, while the Applicant will use no more than one hour giving their oral evidence.
