Introduction

1. On 20 October 2025, the Applicant submitted filings in the Tribunal's Court Case Management System ('CCMS") which do not include an application in the prescribed form. On the Personal Details form, he states that he is USG [Under-Secretary-General] at the Economic Community of West African States (ECOWAS). The Applicant also states he is making a claim as a beneficiary or successor to a deceased staff member (who has the same name as him) and lists his counsel as "Washington, George". He further states that "UNCCD" (perhaps the United Nations Convention to Combat Desertification) took a contested decision which he does not describe.

- 2. The filing attaches four documents as follows:
 - a. under "Main Document (Application)", he attaches a publication of the International Atomic Energy Agency entitled "Safety of Uranium and Plutonium Mixed Oxide Fuel Fabrication Facilities, Specific Safety Guide No. SSG-7 (Rev.1)";
 - b. under "Copy of Contested Decision", he attaches "FinCEN Suspicious Activity Report (FinCEN SAR) Electronic Filing Instructions" dated October 2012;
 - c. under "Management Evaluation Response", he attaches "United States Securities and Exchange Commission Form 10-K" relating to the annual report of The Charles Schwab Corporation"; and
 - d. under "Annexes to the application", he attaches "View from the Back, Ramblings of a Retiree in France, History of the Hotel de Paris, Monaco".
- 3. The Applicant was instructed by the Registry to file a complete application attaching the correct documents by 27 October 2025. He has failed to do so.

Consideration

4. In the absence of a substantive application and noting that the documents currently filed do not appear relevant to any claim, the Tribunal is unable to ascertain if there is a cognizable claim that is within its jurisdiction.

5. The Applicant's failure to comply with the Registry's request for submissions in compliance with the Rules of Procedure makes it impossible to process the case.

6. It is ORDERED that Case No. UNDT/NBI/2025/114 be closed and struck from the Tribunal's docket.
