Along with attracting external funds, the Government of the Republic of Tajikistan, using all its capabilities and resources, invests in healthcare, support for the public and private sectors, environmental issues and key sectors of the economy.

The private sector also was provided with soft loans and tax incentives.

The Government of the Republic of Tajikistan, as a full member of the United Nations and international financial institutions, believes that in this difficult period for all countries of the world, we should unite and support each other as much as possible.

It is well known that the Covid-19 virus, declared a pandemic by the World Health Organization, is an international emergency.

In this regard, the Government of Tajikistan has established effective cooperation with all development partners, including the adoption of the State Budget Support Program as part of this cooperation with the International Monetary Fund.

The International Monetary Fund (IMF) provided the Republic of Tajikistan with a concessional loan in the amount of \$189.5 million.

At the same time, the Asian Development Bank provided a grant of US \$ 50.0 million to support the Republic of Tajikistan.

It also attracted a grant of \$ 11.3 million from the World Bank for the prevention and control of Covid-19.

The funds provided will be directed mainly to the country's health sector and will contribute to the proper provision of medical services, access to medicines, and the provision of doctors with all necessary equipment and materials.

Along with attracting external funds, the Government of the Republic of Tajikistan, using all its capabilities and resources, invests in healthcare, support for the public and private sectors, environmental issues and key sectors of the economy.

The private sector is also provided with soft loans and tax incentives.
