### **24. The situation in the Middle East**

During the period under review, the Security Council held 57 meetings, including six private/closed meetings,<sup>1</sup> in connection with the item entitled “The situation in the Middle East”. The Council adopted seventeen resolutions and seven presidential statements. The Council did not adopt a draft resolution by which the Council would have referred the situation in the Syrian Arab Republic to the International Criminal Court.<sup>2</sup> During the meetings, the Council considered: (a) the humanitarian and political situation in the Syrian Arab Republic; (b) the humanitarian situation and political transition process in Yemen; (c) the mandate of the United Nations Disengagement Observer Force (UNDOF); (d) the situation in Lebanon and the mandate of the United Nations Interim Force in Lebanon (UNIFIL); and (e) the victims of attacks and abuses on ethnic or religious grounds in the Middle East.

The Council renewed the mandate of UNDOF<sup>3</sup> four times for periods of six months<sup>4</sup> each, and renewed the mandate of UNIFIL<sup>5</sup> twice for periods of one year each.<sup>6</sup> In February 2014, the Council established the Committee pursuant to resolution [2140 \(2014\)](#) to oversee the sanctions measures imposed on individuals or entities engaging in or providing support

for acts that threatened the peace, security or stability in Yemen.<sup>7</sup> By resolution [2204 \(2015\)](#), the mandate of the Panel of Experts was extended for 13 months. By the same resolution, the Council renewed the travel ban and assets freeze, imposed by resolution [2140 \(2014\)](#), for 12 months, respectively, and by resolution [2216 \(2015\)](#) the Council expanded the sanctions regime by imposing a targeted arms embargo on designated individuals.<sup>8</sup> In August 2015, the Council also established, for a period of one year, the OPCW-United Nations Joint Investigative Mechanism (JIM) to identify individuals, entities, groups or governments who were perpetrators, organisers, sponsors or otherwise involved in the use of chemical weapons in the Syrian Arab Republic.<sup>9</sup>
