The United Nations Public-Private Alliance for Rural Development (UNPPA), established in 2004, is the third in a series of innovations in recent years for participation by a wider range of stakeholders promoted by the UN Economic and Social Council (ECOSOC). UNPPA is a unique initiative linking actors within and outside the UN system. It focuses on the positive role business can play in promoting development, as well as stimulating entrepreneurial capacity-building and encourages investments, trade and related activities for sustainable rural development.

MISSION

UNPPA identifies, highlights and promotes replication of successful business policies and practices that are both profitable and promoting social and economic advancement of people in rural areas.

OBJECTIVES

- ◆ Work as a catalyst and facilitator for the creation of partnerships;
- ◆ Identify and promote business and commercial relations in several activities;
- ◆ Provide a platform for collaboration; and
- ◆ Bring the results of these efforts to the attention of the international community.

FUNCTIONS

UNPPA promotes business, stimulates entrepreneurial capacity-building. It also encourages investments, commerce and related activities for sustainable rural development by developing multi-stakeholder partnerships. Ultimately, UNPPA's activities help to address the MDGs.

PRESIDENTIAL COMMISSION

The Presidential Commission on the Millennium Development Goals and Sustainable Development (COPDES) was established in 2004. The function of COPDES is mainly to provide a framework for coordination and to monitor progress toward the achievement of the MDGs. COPDES will use the UN Alliance as a catalyst.

The COPDES and some of the Ministries and Task Forces in the Dominican Republic will work with the UN Alliance in strengthening cooperation with the United Nations system organizations to expand partnership with the private sector as well as link with priorities in the ongoing national assessment of needs for meeting MDG targets. The work mainly of the Ministry of Agriculture is closely related to UN Alliance themes. The aim of the COPDES Task Force on Hunger, the “Comer es Primero” programme is to work for poverty reduction through implementation of Task Force strategies and recommendations, including through public-private partnerships for rural development.

- ◆ Reporting to the ECOSOC on progress
- ◆ Coordinating inputs from the stakeholders
- ◆ Substantive servicing of the intergovernmental meetings on UN Alliance

- ◆ Information and Communications Technology

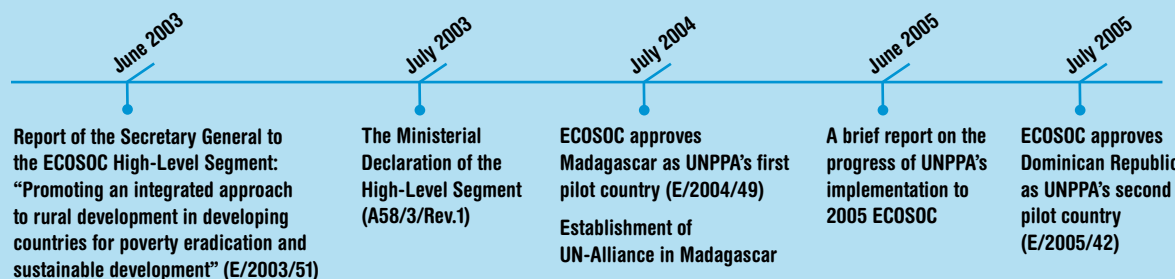
