The goal of these four roundtables is to discuss the main objectives and functions Member States would like to see the 10YFP delivering and identify key elements of the 10YFP that could deliver them. Six functions were identified in the background document #1, "10-Year Framework of Programmes on Sustainable Consumption and Production (10YFP): A review of Options for Institutional Structure": (1) Catalyze political, technical, and financial support through common goals and vision, (2) Build stronger bridges between communities by providing means to share knowledge and network, (3) Support mainstreaming SCP into national policies, the UN and others' work, (4) Support collaboration platforms and partnerships, (5) Establish links, support financing and encourage cooperation and coordination among various technical assistance programmes, (5) Help raise awareness and support civil society engagement. Are there any the 10YFP should not support? Are there some missing? Which? Once functions are agreed upon, key mechanisms to address these functions could start being explored.

Potential criteria to select elements could include: (1) coordinated action at the global, regional and national levels around the desired objectives; (2) flexibility; (3) engagement of all stakeholders including the UN in a concerted and coordinated way; (4) build on and disseminate scientific knowledge on SCP and SCP policies; (5) leverage technical and financial resources.

Other criteria may include: Seizes win-win opportunities; Augments options for producer/consumer sustainable choices; Increases affordability of sustainable choices; Makes information for sustainable choices accessible and easy to understand; Provides or builds on a solid scientific and policy knowledge base; and Offers incentive for social and technological innovation and producer/consumer responsibility.
