Draft programme of work for the biennium 2012-2013 for the Division for Sustainable Development of the Department of Economic and Social Affairs

Note by the Secretariat

- 1. The draft programme of work in the field of sustainable development for the biennium 2012-2013, which is contained in annexes I and II to the present note, is submitted for the consideration of the Commission on Sustainable Development in compliance with the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, Monitoring of Implementation and Methods of Evaluation (ST/SGB/2000/8).
- 2. In its resolution 65/244, the General Assembly approved the biennial programme plan for the period 2012-2013, which includes the elements of the programme narrative, namely, the objectives, expected accomplishments and indicators of achievement of the sustainable development subprogramme (annex I). It also includes a draft programme supporting the preparatory process of the United Nations Conference on Sustainable Development (annex II), which represents a non-recurrent activity mandated by the General Assembly in its resolution 64/236.
- 3. The draft programme of work contained in the annexes to the present note includes, in addition to the programme narrative, a list of outputs formulated within the framework of subprogramme 4 (Sustainable development) of programme 7 (Economic and social affairs) of the biennial programme plan for the period 2012-2013.
- 4. The Commission is invited to take note of the programme narrative and to review the proposed outputs to be included in the proposed programme budget for the biennium 2012-2013, which will be submitted to the Advisory Committee on Administrative and Budgetary Questions and to the General Assembly at its sixty-sixth session.

Annex I

Draft programme of work for the biennium 2012-2013 for the Division for Sustainable Development of the Department of Economic and Social Affairs

The Division for Sustainable Development is responsible for the subprogramme.

Objective of the Organization: to accelerate the implementation of sustainable development goals, targets and commitments in accordance with internationally agreed development goals, including those contained in the United Nations Millennium Declaration and the outcomes of major United Nations conferences and summits, in particular the World Summit on Sustainable Development

Expected accomplishments of the Secretariat

Indicators of achievement

- (a) Effective review of and agreement by Member States on key sustainable development challenges and priority actions of the multi-year programme of work to advance implementation in the areas of forests, biodiversity, biotechnology, tourism, mountains
- (b) Increased accessibility of information, understanding and knowledge on policy options, practical measures and concrete actions needed for the adoption and implementation of sustainable development at the local, national, regional and international levels
- (c) Enhanced technical, human and institutional capacities of developing countries and countries with economies in transition to implement actions and national strategies for sustainable development in energy, water, natural resources, and sustainable consumption and production

Strategy

The strategy will include:

- (a) Promoting and supporting effective, coherent and coordinated implementation of the sustainable development agenda of the United Nations, including Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation, as well as the Programme of Action for the Sustainable Development of Small Island Developing States and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, at the national, regional and global levels, with an emphasis on greater integration of social, economic and environmental dimensions of sustainable development through, inter alia, national sustainable development strategies;
- (b) Providing substantive and effective support, including policy development and analysis, to intergovernmental processes, in particular to the Commission on Sustainable Development and the United Nations Conference on Sustainable Development that will be held in Brazil in 2012;
- (c) Providing coordinated and coherent support to system-wide, inter-agency activities for the implementation of sustainable development goals;
- (d) Providing technical and policy advisory services to Member States, including small island developing States, at their request, to enhance their capacity to develop, implement, monitor and review national sustainable development strategies, and action plans on sustainable consumption and production, as well as actions and strategies to manage water, energy resources, responses to climate change; and to implement effective information, monitoring, review, and reporting systems at the national and regional levels;
- (e) Strengthening cooperation with major groups and identifying opportunities for their further engagement in the work of the United Nations in the area of sustainable development;
- (f) Undertaking in-depth analysis and evaluation of trends in the implementation of sustainable development, including lessons learned, best practices and new challenges, and cross-sectoral analysis of sustainable development in the economic, energy, climate change, water, and natural resources sectors:
- (g) Maintaining and improving transparent, user-friendly and easily accessible websites, including database systems for information on sustainable development;
- (h) Providing information and summary reports on partnerships for sustainable development to the Commission on Sustainable Development and to Member States.

External factors

The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that Governments, international institutions, the United Nations system and other stakeholders give priority to the implementation of

Agenda 21, the Johannesburg Plan of Implementation and other commitments made during the World Summit on Sustainable Development, and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States. The outcome of the United Nations Conference on Sustainable Development, to be held in Brazil in 2012, is also expected to have an impact on the Division's programme of work and its implementation.
