Information for United Nations-funded meeting participants

Please be advised that the current Daily Subsistence Allowance (DSA) Rate for Addis Ababa is \$207. DSA and terminal expenses can be collected at the Commercial Bank of Ethiopia (ECA branch), where the Department of Economic and Social Affairs (DESA) Executive Office will be located, at the Rotunda, ground floor, in the commercial area.

The Executive Office *is open* to United Nations-funded participants, to collect the following documentations:

- (a) Passports;
- (b) Air tickets and itineraries confirming outbound flights from Addis Ababa; and
- (c) Boarding passes confirming inbound flights to Addis Ababa.

Once these documents have been submitted and reviewed, participants may collect their entitlements from the tellers at the bank.
