### Mr. Cyrille Pierre

Deputy Director for Global Economic Affairs and Development
Strategy
General Directorate for Globalization, Development and Partnerships
Ministry of Foreign Affairs, France

Mr Cyrille PIERRE was appointed Deputy Director for global economic affairs and development strategy at the French Ministry of Foreign and european affairs in march 2009 (General Directorate for

globalization, development and partnerships). His Department covers international economic issues (G8, G20, OECD, IFIs...), development strategies (bilateral, european and multilateral issues) and cooperation in the field of democratic governance.

Graduated from the Ecole Nationale d'Administration, the Institut d'Etudes Politiques de Paris and the University of Pantheon-Sorbonne (Public law), he became in 1997 auditor and then counselor at the French Cour des Comptes (National Audit Office, specialized in auditing the Ministry of Justice and the Ministry of Home Affairs), and was appointed Counselor to the Permanent Rep. of France to the European Union in Brussels in 2001 – Economy and trade Division and EU-Asia relations. He joined the Ministry of Foreign Affairs in Paris in 2004 – in charge of G8 issues – special assistant to the French Sous-sherpa - and became in 2006 Head of International financial affairs division of the MFA, Economic and financial affairs Department.

He was involved in innovative financing initiatives since 2004, in particular in the framework of the leading group on innovative financing established in 2006.



# Mr. Edward P. Ross Director Corporate Marketing, Amadeus IT Group

Eddie was appointed Director, Corporate Marketing for the Amadeus IT Group in November 2003. He is worldwide responsible for Amadeus brand strategy, corporate communication, sponsorship, advertising, promotion and web strategy, marketing research and intelligence, and the Amadeus' Executive Briefing Centres around the world.

He has contributed to the Millenniun Foundation Massive Good project since its inception and is a member of the Strategic Advisory Panel on Communication.

Eddie joined Amadeus in 1996 as Manager of Advertising and Promotion before moving on to lead Amadeus marketing communication. In early 2000 he became Marketing Director of Rumbo.com, now Spain's leading online travel agency. There he led all marketing aspects for the start-up of the company. In September 2001 he returned to Amadeus, responsible for the group's internal communication.

Prior to Amadeus, Eddie worked for eight years in the advertising industry, first in London with Saatchi & Saatchi and WCRS – and latterly in Madrid at Ruiz Nicoli (EURO RSCG). He is a graduate in Business Systems Management from the City University in London.

Prior to joining GAVI in March 2010, David Ferreira was the founding investment manager of Soul City Broad-Based Empowerment Company, an investment company owned by the South African non-profit organisation Soul City Institute for Health and Development Communication. David is a non-executive director of ADvTECH Ltd, a listed education company. He also served as a non-executive director of the MIIU Company, which provided financial and technical assistance to South African municipalities seeking to create public-private partnerships.

David was a founding shareholder and director of Praxis Capital, a private equity business focused on South Africa's healthcare and education sectors. Before Praxis, David's background was largely in project and corporate finance. From 1996-97, he established and managed the Private Sector Investments Unit of the Development Bank of Southern Africa. At the World Bank (1992-96), David helped to design new financial instruments to enable governments in Asia and Latin America to attract private financing to infrastructure projects.

David started his career in South Africa in 1984 as a human rights and labour lawyer. From 1988-91 he was with the US law firm Davis Polk & Wardwell, assisting clients with financings in the bank, bond and equities markets.

David is a Rhodes Scholar, with an MSc from the London School of Economics, an MA from Oxford University, and BA and LLB degrees from the University of the Witwatersrand.

David is also the Head of GAVI's Washington DC Office.



Ms. Susan McAdams

Susan McAdams heads the World Bank department responsible for multilateral innovative financing initiatives, and for financial management and trust administration of multilateral development funds, including the Global Fund to Fight AIDS, Tuberculosis and Malaria, the Global Environment Facility, the Adaptation Fund under the Kyoto Protocol, and the Heavily Indebted Poor Countries Debt Initiative. She led the World Bank's engagement in the design, negotiation and implementation of the International Finance Facility for Immunisation and of the pilot Advance Market Commitment for vaccines against pneumococcal diseases. She joined the World Bank in 1992, and acted as finance counsel with respect to the Bank's financial policy and Treasury services and transactions, and Lead Counsel for the International Development Association.

Prior to joining the Bank, Ms. McAdams was an associate at Cleary, Gottlieb, Steen & Hamilton, where her practice focused on corporate and securities law, structured finance, and asset securitization transactions. She was an associate with an international and securities transaction practice at Hamada & Matsumoto in Tokyo and Covington & Burling in Washington, DC.

Ms. McAdams received her JD and MPP degrees in 1985 from Harvard University. She received her BA *magna cum laude* from Middlebury College, and attended l'Institut d'Etudes Politiques in Paris.



#### Ms. Ellen F.M. 't Hoen, LL.M.

Ellen 't Hoen is the Senior Adviser for Intellectual Property and Medicines Patent Pool at UNITAID

She is a lawyer and an expert in medicines policy and intellectual property law. From 1999 until 2009 she was the Director of Policy and Advocacy at Médecins sans Frontières' (MSF) Campaign for Access to Essential Medicines. In 2008 she was a research fellow at the IS HIV/AIDS Academy of the University of Amsterdam. She is the author of the book "The Global Politics of Pharmaceutical Monopoly Power. Drug patents, access, innovation and the application of the WTO Doha Declaration on TRIPS and Public Health." which was published in January 2009.

UNITAID is an innovative financing mechanism primarily based on air ticket tax levied by participating countries. UNITAID's mission is to contribute to scaling up access to treatment for HIV/AIDS, malaria and tuberculosis, primarily for people in low-income countries, by leveraging price reductions for quality diagnostics and medicines and accelerating the pace at which these are made available.
