## **ACTIVITIES FUNDED:**

(a) Consultants: fee for preparing six papers customizing national development strategy papers for the Arab world;

- (b) Contractual printing and other services, including: (a) publishing 250 copies of customized Arabic book on National Development Strategies: Policy Notes; and (b) purchase of 200 copies of a book entitled "Realizing the Development Potential of Diasporas";
- (c) Travel of representatives to attend official events of the FfD follow-up process, including: (a) consultations between the ECOSOC Bureau and the Executive Boards of the World Bank and IMF (1 March 2011, Washington DC); (b) Panel Discussion on "Building on Istanbul: Financial support for development efforts of LDCs", held during ECOSOC Coordination Segment (12 July 2011, Geneva);
- (d) Travel of staff to attend multi-stakeholder consultations, conferences, regional meetings and other events on the follow-up to the Monterrey Consensus and Doha Declaration on Financing for Development and representation of DESA at various meetings on FfD-related matters.
