High-level Dialogue on Financing for Development (7-8 October 2013)

The organizational arrangements are described in General Assembly resolution 67/300 of 16 September 2013. A letter from the President of the General Assembly, dated 25 September 2013, was sent to all permanent representatives and permanent observers.

Statements for the formal plenary meetings should not exceed *five minutes* when speaking in a national capacity, and *seven minutes* when speaking on behalf of a group. Interventions in the interactive round table discussions should not exceed *three minutes* each. Intervention in the interactive dialogue should not exceed *three minutes* when speaking in a national capacity, and *five minutes* when speaking on behalf of a group.
