Quadrennial Programme of Work 2017-2020

UN organizations, other international, regional and subregional organizations and processes, as well as nongovernmental partners are encouraged to contribute to the implementation of the United Nations Strategic Plan for Forests 2017-2030 (UNSPF) through their work programmes, and consistent with their mandates.

The Quadrennial Programme of Work (4POW) is the contribution of the United Nations Forum on Forests to implement the UNSPF, which sets out priority actions and resource needs, beginning with the period 2017-2020.

The thematic priorities/areas of actions of the sessions of the United Nations Forum on Forests are determined by the Forum and guided by the UNSPF. (*Ref E/2015/33 para 40*)

The 4POW 2017-2020 will be a matrix which identifies two sets of priority actions: (i) operational priorities called for in E/2015/33 and the UNSPF; and (ii) thematic priority (ies) and associated actions linked to the Global Goals and associated targets.

Thematic priorities/areas of actions, and resources needs for UNFF12-15 will be considered at AHEG2, taking into account the need to align them with the eventual Global Goals and associated targets, as well as actions of the UNSPF.
