THE PERMANENT MISSION OF ECUADOR TO THE UNITED NATIONS, in this regard, wishes to forward the following VNC from Ecuador:

On Global forest goal 1: Reverse the loss of forest cover worldwide through sustainable forest management, including protection, restoration, afforestation and reforestation, and increase efforts to prevent forest degradation and contribute to the global effort of addressing climate change,

Specifically in the fulfillment of the goals detailed below:

- a) 1.2. The world's forest carbon stocks are maintained or enhanced.
- With the implementation of the REDD + Action Plan "Forests for Good Living", Ecuador seeks to reduce gross emissions by at least 20% by 2025, from the Forest Emissions Reference Level for Deforestation 2000-2008 (43'418,126 tons CO2) eq / year), taking into account REDD + policies, measures and actions focused on reducing deforestation.

- b) 1.3. By 2020, promote the implementation of sustainable management of all types of forests, halt deforestation, restore degraded forests and substantially increase afforestation and reforestation globally.
- Ecuador is at the design and structuring phase of its National Forestry Management Plan, which seeks to determine the strategic lines for forest management of all types of forests present in its continental territory;
- By 2030, Ecuador has envisioned a goal of zero net deforestation at the national level.

THE PERMANENT MISSION OF ECUADOR TO THE UNITED NATIONS avails itself of this opportunity to renew to the United Nations Forum on Forests Secretariat in New York the assurances of its highest consideration.
